This book is intended for system administrators, implementors, on-site technicians, and Remote Service Center personnel supporting the Intuity system.

Procedures are provided only for MERLIN LEGEND system-specific items and for new Intuity features not described elsewhere.

Chapter A, "System Security and Toll Fraud"

This appendix provides important information for securing the system against telecommunications fraud. Review the information in this appendix before starting the switch integration process.

Chapter B, "Installing MERLIN LEGEND Software on the Intuity System"

This appendix contains procedures for installing the MERLIN LEGEND switch integration software on the Intuity system.

Chapter C, "Switch Administration for INTUITY Lodging"

This appendix contains information about installing the MERLIN LEGEND switch integration with an Intuity system operating the Intuity Lodging application.

## MERLIN LEGEND Integration Concepts

# 1

This chapter contains information that describes the Intuity system and explains how the Intuity system and the MERLIN LEGEND Communications System work together.

## Introduction

The AT&T Intuity AUDIX<sup>®</sup> Voice Mail System (Intuity AUDIX) and the AT&T Intuity Intro Voice Response System (Intuity IVR) provide business-oriented, computerized voice services in support of a telecommunications system.

The Intuity system uses voice prompts and announcements to guide callers in sending and receiving voice messages through the use of touch-tone buttons on the caller's telephone. Intuity AUDIX can be used as a personal answering service, a messenger to individuals or groups, an information service, an office receptionist, and as an automated attendant service. Intuity Intro Voice Response can be used to develop sophisticated voice applications tailored for a specific customer.

Intuity AUDIX and Intuity Intro Voice Response are software application packages that build upon the Intuity service layer and the Intuity processing platform layer. (Refer to Figure 1-1.) The elements of the Intuity service layer and the Intuity processing platform layer are accessible to any application package above them. By putting common elements such as switch integration, digital networking, voice processing, call control, and system administration into the service layer, these facilities can be used by all current and future application packages. Developing the Intuity system with the processing platform layer as its base keeps reliability and maintainability as a focus throughout the product. The processing platform layer contains utilities and tools that the layers above it can use, such as alarm processing, backup and restore utilities, activity logs, and the operation, administration, and maintenance interface. The hardware of the processing platform layer includes the Multi-Application Platform (MAP) chassis with the central processing unit (CPU), memory (RAM), hard disk drive(s), removable media drives (floppy diskette and tape) and the UNIX operating system.

The service layer includes the voice processing platform, Intuity AUDIX Digital Networking, and switch integration. The service layer is similar to the processing platform layer in that it provides tools and utilities to the applications packages, but it is more specific in its offerings. The service layer includes hardware and software components integral to the services offered — the IVC6 voice card for processing speech, the AUDIX communications controller for Intuity (ACCX) card for digital networking, and system administration software for elements that span the platform such as voice port administration.

The application package layer contains independent programs that meet a specific business need. The Intuity AUDIX Voice Mail System relies heavily on the foundation established by the services and processing platform layers

## **Switch Integration Concepts**

*Switch integration* refers to the sharing of information between a voice messaging system and a switch in order to provide a seamless interface to callers and subscribers. A fully integrated voice messaging system uses information taken directly from the switch to determine how to process each incoming phone call. (Refer to Figure 1-2.) Integrating the Intuity system and a MERLIN LEGEND switch does not require special equipment — the MERLIN LEGEND system sends call information by touch-tones over the same voice circuits used for call processing.



Figure 1-2. Call Routing

To understand how Intuity system applications are integrated with the MERLIN LEGEND Communications System, the following definitions will be useful (more detailed definitions are available in the MERLIN LEGEND Communications System documentation):

Coverage Path

When a call is not answered because the called station is busy or because the called station has not answered within a specified number of rings, the call is sent to the next point in the coverage path. This may be a secretary, an attendant, etc. The last, or possibly only, coverage point is a calling group that sends calls to the Intuity AUDIX system.

Coverage Group

Group coverage is an arrangement in which a special coverage group acts as a routing point for a group of extensions whose coverage is handled in the same way. Calls that are not answered by a member of the coverage group are sent to the Intuity AUDIX system by programming a voice messaging interface (VMI) calling group as the receiver for the coverage group.

Voice Message Interface (VMI) calling group

A VMI calling group has the following characteristics:

- Calls to the group extension ring at the first available station. (That is, each call rings at the first available station from the beginning of the list of stations.) This is called "linear hunt."
- Trunks can be set to "ring in" to the calling group so that an incoming trunk call goes directly to the first available station.
- The calling group can be programmed as the receiver for a coverage group so that unanswered calls to the members of the coverage group automatically go to the first available station for coverage.
- An integrated VMI calling group provides call information to the voice port receiving each call. The call information allows the Intuity AUDIX system to determine:
  - If the call being processed was a direct call or a coverage call
  - If the call was a direct inside call (to the calling group number) or a direct outside call (on one of the trunks assigned to ring into the calling group)
  - If the coverage is for one extension calling another, or for a call made from outside (trunk) to an extension

#### **NOTE:**

In a *generic* VMI calling group, call information is not supplied. A generic VMI group is used for Intuity IVR applications only.

Coverage for calls is provided by assigning a call *coverage group* as the last point of each extension's coverage path. The calling group for the Intuity voice ports is then programmed as the receiver for the call coverage group.

Additional information required for coordination of the Intuity system and the MERLIN LEGEND system is passed in both directions by touch-tones. The Intuity system and the MERLIN LEGEND system also communicate by switch-hook flashes and call progress tones.

Some features provided on other AT&T switches do not have corresponding call information on the MERLIN LEGEND system. For example, on DEFINITY/System 75 switches, a code indicates whether the reason for coverage is BUSY or NO ANSWER. As a result, the Intuity system can provide different personal greetings based on this information on the DEFINITY/System 75, but not on the MERLIN LEGEND system. Similarly, the Day Service/Night Service feature available on the MERLIN LEGEND system cannot be provided on the DEFINITY/System 75.

## **Intuity AUDIX Voice Mail Services**

Intuity AUDIX is easy to operate. Callers receive spoken prompts to guide them in making choices by pressing the appropriate touch-tone button on the telephone.

Intuity AUDIX can be administered to provide the following kinds of services (examples):

Call Answer

When the extension originally called is busy or there is no answer, Intuity AUDIX allows the caller to leave a message, transfer to another extension, or transfer to an attendant. The person called (subscriber) may provide a personal greeting to callers or select a standard system greeting. The subscriber may set up a password to help protect against unauthorized access to messages. Messages can be picked up from the office or from an outside telephone.

The outcalling feature allows Intuity AUDIX to call a subscriber when a new message arrives. The subscriber can specify the telephone or pager number to be called.

The call is passed from the MERLIN LEGEND system to the Intuity system with call information that indicates the covered extension number and whether the call was from an internal station or received on a trunk from outside. Based on this information and on caller actions indicated by pressing touch-tone buttons, the Intuity system can accept a message for the called extension's voice mailbox or provide other special processing. Voice Mail

Voice mail services allows subscribers to send voice messages to other subscribers, listen to received messages, forward messages received with comments attached, reply to messages, and return calls to other subscribers who left messages. Subscribers can create and edit group lists and send messages to one or more groups.

Voice mail services also allow the system manager to send broadcast messages to everyone on the system.

When a subscriber has "new" voice messages in their mailbox, voice mail turns on the subscriber's message waiting indicator.

Voice mail may be accessed from internal stations by dialing the extension for the calling group that contains the Intuity system voice ports or from outside by calling in on a trunk that is administered to ring at the Intuity system voice port calling group.

The call is passed from the MERLIN LEGEND system to the Intuity system with call information that indicates the call was received directly in the calling group and includes the calling extension number or trunk number.

Automated Attendant

An automated attendant directs callers through a series of menu selections to reach a desired department, extension, or attendant. Callers are greeted with spoken prompts that guide them in pressing touch-tone buttons to connect to their desired destination. If there is no answer or the desired extension is busy, the caller may leave a message or transfer to an attendant.

An automated attendant can be used in a primary call handling mode or a secondary call handling mode:

- In primary call handling mode, the automated attendant answers incoming calls as they are received. A receptionist backs up the automated attendant by handling overflow calls and calls from people needing assistance (for example, time-outs and dial 0).
- In secondary call handling mode, a receptionist answers as many calls as possible and the automated attendant handles any overflow calls.

The Intuity system allows multiple automated attendants. Each automated attendant may have separate menus for day and night service and custom service for special hours and for holidays.

The call is passed from the MERLIN LEGEND system to the Intuity system with call information that allows the Intuity system to provide automated attendant processing based on the trunk on which the call is received and/or on the number that was called.

**Bulletin Board Service** 

Bulletin Board service (also called Information service) is a call-in information facility. The caller hears a prerecorded, informational message and is then disconnected.

The call is passed from the MERLIN LEGEND system to the Intuity system with call information that allows the Intuity system to provide information service processing based on the trunk or extension on which the call is received.

Alternately, bulletin board service can provide multiple messages by using a menu within an automated attendant.

## **Intuity Intro Voice Response**

Intuity IVR is an application development environment or toolkit for building customized business applications. Calls are routed to the Intuity IVR application based on specific numbers called (within a shared calling group) or by using a dedicated calling group for the application.

## Port Considerations

The MAP/5 and the MERLIN LEGEND system each impose some limitations on the number and arrangement of voice ports when used with the Intuity system. The choice of how to implement these ports may be based in part on the following hardware constraints:

The MAP/5 is limited to a maximum of 18 voice channels with up to four digital networking channels. (This is a physical space limitation.)

#### $\blacksquare$ NOTE:

For the MAP/40 and MAP/100, the MERLIN LEGEND system restrictions described in the following bullet are the only limiting factor.

Intuity hardware considerations aside, MERLIN LEGEND calling groups can contain a maximum of 20 extensions for voice ports. A maximum of 20 voice channels are supported for all applications connected to a single calling group. If more than one calling group is used, a total maximum of 24 voice channels distributed among several groups are supported.



All Intuity AUDIX voice ports must be in the same calling group.

Because of these constraints, the channel assignment strategy for the Intuity system with the MERLIN LEGEND system may differ considerably from the strategy that would be used with other switches where these constraints are not present. In particular, the types and volumes of call traffic may allow alternative approaches. The following strategies can be used:

Single Group of Shared Ports

A single group of shared ports is the simplest, most flexible and powerful strategy from a traffic handling point of view, but it is limited to one calling group with a maximum of 20 ports. If no Intuity IVR applications are installed on the system (that is, only Intuity AUDIX is used), you should use this arrangement.

#### **NOTE:**

Intuity AUDIX and Intuity IVR calls are directed to the same calling group. The calls are then handled based on the called number information.

A single calling group allows the Intuity system to use idle channels to meet the immediate needs of any type of incoming call. The Intuity system determines its resource allocation based upon current demand. All channels may respond to any call by identifying the number that has been called, associating it with the requested service, and providing the requested service.

A single calling group must be defined on the MERLIN LEGEND system as an *integrated* VMI calling group.

Shared Ports Group with a Dedicated Ports Group

A dedicated calling group reserves ports and trunks for specific applications, guaranteeing availability regardless of other traffic. It is useful only for a single Intuity IVR application.

Calling groups that contain only Intuity IVR ports and trunks for a single Intuity IVR application must be defined on the MERLIN LEGEND system as *generic* VMI calling groups.

#### **NOTE:**

The use of a dedicated ports calling group is the only way that more than 20 ports can be used on a MERLIN LEGEND system. A maximum of 24 ports total can be used on the MAP/40 or MAP/100. A maximum of 18 ports total can be used on the MAP/5.

#### **Intuity Port Administration**

Intuity port administration consists of two steps:

- Defining the extension associated with a physical port (channel) and the initial service associated with that port (DNIS\_SVC or dedicated Intuity IVR application)
- 2. Defining the service associated with a specific called number when the initial service is DNIS\_SVC (dedicated Intuity IVR application or AUDIX)

#### > NOTE:

Do not confuse DNIS\_SVC (a specific value used in a field for Intuity system channel service specification) and DNIS as it relates to T1 trunk service available on the MERLIN LEGEND Communications System.

#### **Dynamic Allocation or Shared Ports**

With dynamic allocation or shared ports, the processing assigned to each call is based on the Dialed Number Information Service (DNIS) information (call information) included with the call. In this case, the calling group must be defined as an *integrated* VMI calling group on the MERLIN LEGEND system, and each port (channel) must have DNIS\_SVC defined as its associated service.

A service assignment table is then defined to associate the called number (or trunk) with its final processing destination. For each specific called number (or trunk), an Intuity IVR application name can be specified. At the end of the table, the entry ANY in the called number field and the service AUDIX are used to send all calls not otherwise processed to Intuity AUDIX for processing.

#### **Dedicated Allocation**

With dedicated ports, the processing assigned to each call is based on the port (channel) on which the call is received. The Intuity IVR calling groups must be defined as a *generic* VMI calling group on the MERLIN LEGEND system, and each port (channel) must have a specific Intuity IVR application defined as its associated service. There is no service assignment table required, and there is no call information passed from the MERLIN LEGEND system to the Intuity system.

## **Automated Attendant Enhancements**

A number of automated attendant enhancements have been made to Release 2.0 of Intuity AUDIX to meet customer needs and to provide feature parity and migration paths for customers using the AT&T AUDIX Voice Power system on the MERLIN LEGEND system. These new features include:

- A mapping table that can be used to route incoming calls to automated attendants based on the incoming Trunk ID
- Automated attendant operation based on business schedule(s)
- Automated attendant operation based on switch Night Service status
- Automated attendant operation based on holiday schedule(s)

This section describes the various ways the Intuity AUDIX automated attendant service can be set up to meet specific call handling needs.

#### Primary and Secondary Automated Attendant Concepts

A business can deploy automated attendant service in either primary or secondary mode.

Primary Mode

In primary mode an automated attendant system is expected to answer all incoming calls. The company receptionist backs up the automated attendant by handling overflow calls and calls from people needing assistance such as timeouts or dial [0].

Secondary (Backup) Mode

In backup mode the company receptionist is expected to answer as many calls as possible. The automated attendant service backs up the company receptionist by handling calls he/she is unable to answer.

#### Automated Attendant Operation Schedule

Customers may use the Intuity AUDIX automated attendant service to answer incoming calls on a 24-hour/day basis or at night only, depending upon their business needs. Typically businesses are considered open during the day and closed during the night. The term *day* indicates the hours during which the business is open and *night* indicates the hours during which the business is closed.

Intuity AUDIX can use its own weekly business schedules to determine hours for day and night operation or it can rely on the telephone system to indicate when it should operate in day mode and when in night mode. The MERLIN LEGEND system can provide day/night status to Intuity AUDIX. Some other telephone systems cannot.

Some businesses require the automated attendant to play a different menu and/or handle calls slightly differently during lunch time. Other businesses may need a transition automated attendant to handle callers from other time zones. The alternate service hours feature provides a way to do this. This feature is independent of whether the business schedule is set to follow the telephone system night service status.

# Automated Attendant Operation Based on MERLIN LEGEND Status

The MERLIN LEGEND system can be administered to switch from day mode to night mode operation either by a schedule administered on the system or by pushing a Night Service button on the attendant console. The advantage of linking Intuity's automated attendant service schedule to the MERLIN LEGEND system status is that the two are then guaranteed to be synchronized.

#### **NOTE:**

The MERLIN LEGEND system can be programmed to route calls differently when Night Service is in effect. This feature can be used to provide automated attendant service only when the MERLIN LEGEND telephone system is in Night Service mode.

#### Automated Attendant Operation Based on Intuity AUDIX Business Schedule

Some businesses de-couple their automated attendant operation from the telephone system's Night Service status and instead control it by the Intuity AUDIX weekly business schedule. Each Intuity system can have up to four weekly business schedules (for example, the Sales and Service divisions may have completely different work schedules). In each of the four schedules, the administrator can specify whether the telephone system Night Service status is to be followed or if entries in the schedule are to be followed. This gives the flexibility needed for the sales division to follow a weekly business schedule for its automated attendant service and for the services division to use the telephone system Night Service status to control its automated attendant service.

Businesses can also specify alternate service hours for additional flexibility. This allows businesses to handle calls more professionally during lunch time. It can also be used by an organization spread across several time zones to handle calls appropriately when one location is closed but the other is open. Businesses can use the MERLIN LEGEND system Night Service status to drive the automated attendant operation but still use the weekly business schedule for alternate service hours operation.

#### Automated Attendant Holiday Operation

Most businesses would like to play different greetings and handle calls differently on holidays. Intuity AUDIX system allows customers to use four different holiday schedules. Each holiday schedule can include up to 26 holidays and the automated attendant (mailbox) to be used for each of those holidays. This allows customers to use a different holiday schedule for the sales division (opened on Columbus day) and the services division (closed on Columbus day). It also allows them to administer different automated attendant greetings and menu options for each of those holidays.

#### Automated Attendant Tenant Service Operation

Sometimes a single telephone system and voice messaging system is shared by several small businesses, or a business has several divisions under the same roof. Intuity AUDIX can provide superior automated attendant service in these cases by creating multiple main-level automated attendants and routing specific calls to each depending on which trunk the call arrives on.

# Primary Automated Attendant Implementation on the MERLIN LEGEND System

When a business uses the Intuity AUDIX automated attendant service in primary mode, calls are administered to ring immediately at the Intuity AUDIX automated attendant service. This is done by administering the trunks to ring at a MERLIN LEGEND integrated VMI calling group (a special type of calling group) whose members are the Intuity system voice ports.

The MERLIN LEGEND system sends the trunk number to Intuity AUDIX for direct (non-coverage) external calls. The Intuity AUDIX routing table maps the trunk numbers received from the telephone system to the automated attendant mailbox numbers.

Customers may want to play different automated attendant greetings and/or handle calls differently during day and night times. This is done by specifying different automated attendant mailboxes for day and night times in the automated attendant routing table. The routing table also allows customers to specify an automated attendant mailbox for handling calls during the alternate service hours.

#### Secondary Automated Attendant Mode Implementation on the MERLIN LEGEND System

Automated Attendant service may be used in secondary mode to back up the receptionist. Intuity AUDIX identifies coverage calls for the receptionist and routes these calls to an appropriate automated attendant mailbox. Anytime an external coverage call is received, Intuity AUDIX uses the appropriate automated attendant mailbox number in the routing table as the called party, taking into account holidays and time of day. If no matching entry is found, the called party number received from the telephone system is used to provide standard Call Answer service.

This scheme allows a business to play different greetings and menus depending on whether the telephone system is in day or night mode, even when the automated attendant service is configured to operate in backup mode.

# Night Only Operational Mode Implementation on the MERLIN LEGEND System

Some businesses use automated attendant service only when the business is closed. The MERLIN LEGEND system is administered to send calls to the Intuity AUDIX calling group when MERLIN LEGEND system Night Service feature is activated.

A business may want night time calls to go to a night service operator. Only when this operator is unable to answer these call are they redirected to the Intuity AUDIX system. This can be implemented by specifying the night service operator as the Night Service answering position on the telephone system side and then covering this answering position with Intuity AUDIX. The routing table can be used to map the night service answering position extension to an automated attendant mailbox.

#### General Call Handling by the Intuity System: Routing Table

As discussed in "Port Considerations" earlier in this chapter, calls for Intuity AUDIX are processed through DNIS\_SVC. Intuity AUDIX then processes the call based on the called number as follows:

- If the called number is defined as a regular voice mailbox, call answer service is provided.
- If the called number is defined as a bulletin board extension, bulletin board service is provided.
- If the called number is defined as an automated attendant mailbox, automated attendant service is provided.

To expand upon the possibilities for incoming calls, three special tables are used. The matching and substitution sometimes come from the same table and sometimes from different tables. (This is clearer if you refer to the processing flow chart in Figure 1-3.)

Routing Table

The routing table is provided for the following reasons:

- To specify different automated attendant menus for calls on different trunks
- To specify different call handling by automated attendants based on a business schedule or the switch night service status
- To provide specialized call handling for holidays
- To provide voice mail login service for calls on specific trunks

The routing table can have up to 25 entries. Each entry has the following columns:

- Incoming Called Number (or range)
- Business Schedule
- Holiday Schedule
- Day Service Mailbox
- Night Service Mailbox
- Alternate Service Mailbox

Each incoming call is matched to the Incoming Called Number column in the routing table:

- 1. If an incoming call is to one of the numbers in the table, further examination is made of Business Schedule and Holiday Schedule columns. Otherwise, the call is passed directly to Intuity AUDIX.
- 2. If the specific tag, "login" in the Business Schedule column is found, the call information is altered to cause the call to be passed directly to voice mail and receive login service when it reaches Intuity AUDIX.
- 3. Next, the current date is matched against the Date column of the holiday schedule, if any, specified in the Holiday Schedule column of the routing table. If the date matches a holiday, the automated attendant extension specified in the Mailbox column of the holiday schedule is substituted for the original called number and the call is passed to Intuity AUDIX.

#### **NOTE**:

The substitution is from the holiday schedule.

4. If a holiday match is not found, the current time is matched against the Alternate Service Hours columns for the current day of the week in the business schedule, if any, specified in the Business Schedule column of the routing table. If the current time is within the specified range, the automated attendant extension specified in the Alternate Service Mailbox column of the routing table is substituted for the original called number, and the call is passed to Intuity AUDIX.

#### $\blacksquare$ NOTE:

The substitution is based on the business schedule, but is from the routing table, not from the business schedule.

5. If no match is found, and the business schedule, if any, specified in the Business Schedule column of the routing table is set to follow the switch night service status, the automated attendant extension specified in the Day Service Mailbox or Night Service Mailbox of the routing table, depending on the switch night service status, is substituted for the original called number, and the call is passed to Intuity AUDIX.

#### $\blacksquare$ NOTE:

The substitution is based on the business schedule, but is from the routing table, not from the business schedule.

6. Finally, if the current time is during the day service hours specified in the business schedule, if any, specified in the Business Schedule column of the routing table, the automated attendant extension specified in the Day Service Mailbox column of the routing table is substituted for the original called number, and the call is passed to Intuity AUDIX. Otherwise, the automated attendant extension specified in the Night Service Mailbox column of the routing table is substituted for the original called number, and the call is passed to Intuity AUDIX.

#### **NOTE:**

The substitution is based on the business schedule, but is from the routing table, not from the business schedule.

Business Schedule(s)

A maximum of four business schedules may be defined. The name or number of one of these business schedules is placed in the Business Schedule column of the routing table to associate the particular business schedule with a called number or range specified in the Incoming Called Number column of the routing table.

Each business schedule has the following fields and columns:

- Business Schedule (name)
- Follow Switch Night Service Status (y/n)
- Day of Week
- Day Service Hours Start
- Day Service Hours End
- Alternate Service Hours Start
- Alternate Service Hours End

#### **NOTE:**

These fields and columns are used for matching only. The automated attendant extensions associated with a match are taken from the routing table. The Business Schedule name is arbitrary and can be changed to indicate the use of the specific schedule. It may contain up to eight letters or digits. The default names are "bus1" through "bus4".

If the Follow Switch Night Service Status field is specified as **y**, the day service hours start and end times must all be blank. (The alternate service hours can still be specified.)

The Day of Week column is fixed. To specify night service 24 hours a day, leave the start and end times blank. To specify day service 24 hours a day, use **00:00** as the start time and **23:59** as the end time. Alternate service hours are also specified on a 24 hour clock.

Holiday Schedule(s)

A maximum of four holiday schedules may be defined. Each holiday schedule can have up to 26 entries. The name or number of one of these holiday schedules is placed in the Holiday Schedule column of the routing table to associate the particular holiday schedule with a called number or range specified in the Incoming Called Number column of the routing table.

Each holiday schedule has the following fields and columns:

- Holiday Schedule (name)
- Holiday Name
- Date
- Mailbox

#### $\blacksquare$ NOTE:

The Date column is used for matching. The automated attendant extension associated with a match is taken from the Mailbox column of this same table. The Holiday Name column is for documentation only.

The Holiday Schedule name is arbitrary and can be changed to indicate the use of the specific schedule. It may contain up to eight letters or digits. The default names are "hol1" through "hol4."

# Other Features of Particular Interest for the MERLIN LEGEND System

A number of features of Intuity AUDIX are of particular interest to customers who are migrating from AT&T AUDIX Voice Power:

- Intuity AUDIX allows multiple main automated attendants
- MERLIN LEGEND Communications System Release 3.0 has a new feature called Direct to Voice Mail (DVM) that can be assigned to a button to send calls directly to voice mail without ringing at the called extension.

# **Multiple Automated Attendants**

Because Intuity AUDIX implements automated attendants as a special type of mailbox, it is possible to have multiple main automated attendants in one Intuity system. An incoming call is transferred to the mailbox specified by the called number, which may be the dialed number, a trunk number, or a mailbox substituted through the routing tables that process the call before it reaches Intuity AUDIX.

An automated attendant mailbox plays a menu instead of a greeting and recognizes touch-tones. It will not accept messages directly, but will transfer, based on touch-tones, to extensions or to other mailboxes that may be submenus, accept messages, or play announcements. If no touch-tone is detected within a specified time-out, the automated attendant will transfer to a default location.

Automated attendants can be set up as the primary call handler with a receptionist for overflow and special handling, or they can be set up as a secondary call handler to back up a receptionist. In the primary configuration, incoming calls ring directly into the Intuity AUDIX calling group. In the secondary configuration, coverage from the receptionist goes to an automated attendant instead of a mailbox.

# Direct to Voice Mail (DVM) Button

A Direct to Voice Mail (DVM) button is available as a new feature on the MERLIN LEGEND Communications System, Release 3.0. When a caller presses this button before making or transferring a call, the call goes directly to voice mail for the called extension without ringing at the called extension.

# **Functionality Differences for the MERLIN LEGEND System**

Integrating the Intuity system with the MERLIN LEGEND switch has the following differences from other supported switches:

- Playing a different personal greeting for BUSY and NO ANSWER is not supported because the MERLIN LEGEND Communications System does not provide the reason for a coverage call.
- High-speed digital networking is not supported.
- Providing appropriate automated attendant service using MERLIN LEGEND Night Service status *is* supported through a business schedule and the routing table.

# **Planning the Integration**

Before you integrate the MERLIN LEGEND system with the Intuity system, you must plan the process. This chapter provides information about both the MERLIN LEGEND system and Intuity system planning worksheets and administration forms to help record information needed for integration on both sides.

MERLIN LEGEND system Release 3.0 forms are located in *MERLIN LEGEND Communications System, Release 3.0, System Planning.* 

MERLIN LEGEND system Release 2.1 forms are located in *MERLIN LEGEND* Communications System, Release 2.1, System Planning.

All Intuity System forms are located in *Intuity New System Planning for Release 3.0* 



For information about using Automated Attendants for INTUITY FAX Messaging, refer to *Intuity New System Planning for Release 3.0*, Chapter 2, "Planning for Intuity AUDIX Automated Attendants," "Automated Attendant for MERLIN LEGEND Fax Call Answer Interceptions or Transfer to an Intuity AUDIX Mailbox."

# MERLIN LEGEND Integration Planning

To plan for the MERLIN LEGEND Communications System side of the integration, complete the following information on the MERLIN LEGEND system forms:

- Application Names (Form 1)
- Number Plan (Forms 2a, 2b, 2c, 2d)

- Voice Ports (Form 2a)
- Intuity AUDIX Subscribers (Form 2a)
- Loop-Start Reliable Disconnect (Form 2c)
- Intuity System Trunks (Form 2c)
- Group Coverage (Form 7c for Release 3.0; Form 6d for Release 2.0)
- Group Calling (Form 7d for Release 3.0; Form 6e for Release 2.0)
- Restrictions and Allowed and Disallowed LIsts (Forms 6e, 6f, and 6g for Release 3.0; Forms 6g, 6h, 6i for Release 2.0)
- Night Service (Form 9a for Release 3.0; Form 7a for Release 2.0)

#### **Application Names**

All applications in use with a MERLIN LEGEND system are listed on Form 1, pages 3 and 4 for documentation purposes. (They are not input to the switch.) To maintain Form 1, on page 4:

- 1. Check the "Other" box.
- 2. Check a box below the "Other" box, and write Intuity on the line provided.
- 3. In the "Notes" section, include any pertinent information. (For example, Intuity AUDIX or Intuity IVR.)

#### Number Plan

The Intuity system requires that the switch have a fixed-length number plan (at least for extensions that have mailboxes or can be transferred to or from the Intuity system). The MERLIN LEGEND system can have a fixed three-digit or four-digit number plan. The Intuity system will not work with a MERLIN LEGEND variable length number plan or with a two-digit number plan. To renumber the MERLIN LEGEND extensions, follow these steps:

- 1. Depending on the numbering plan you are using, check "3-Digit" or "Set Up Space" under the "Renumber System" heading on Form 2a.
- 2. Write the new extension numbers in the "Renumber To" column on Form 2a, Form 2b, Form 2c, and Form 2d as needed.

#### **Voice Ports**

Voice ports used for communication between the MERLIN LEGEND system and the Intuity system must be assigned on a BTM-012 module (Basic Telephone Module-12).

#### **NOTE:**

The OPX module cannot be used for voice ports connected to the Intuity System.

To assign these ports, use Form 2a and follow these steps:

- 1. Determine the logical ID ("Log. ID" column) for each port. Be sure the ports are located on BTM-012 modules and that the configuration rules (see Chapter 4) have been followed.
- 2. In the "Jack Type" column, check "B" for each Intuity system port.
- 3. In the "Person, Location, or Function" column write Intuity.

#### **Intuity AUDIX Subscribers**

As a cross-check for assigning Intuity AUDIX subscribers to coverage, on Form 2a check the "AUDIX Voice Power" column for each subscriber's extension.

#### Loop-Start Reliable Disconnect

Loop-start CO lines used with a voice messaging system must have reliable disconnect to signal when the calling party has hung up. Without reliable disconnect, voice ports may remain engaged for long periods of time without being used. Reliable disconnect must be obtained from the central office and administered on the MERLIN LEGEND system for proper processing. To specify reliable disconnect, use Form 2c. Check "Yes" under "Reliable Disconnect?" at the top of the form.

#### **Intuity System Trunks**

As a cross-check for assigning trunks to ring directly into Intuity system functions such as automated attendants, bulletin boards, or Intuity IVR applications, on Form 2c write one of the following identifiers in the "Function" column:

- AA For Automated Attendant (you may want to include the mailbox number.)
- VM fOr Voice MailBB For Bulletin Board (you may want to include the mailbox number.)
- name For Intuity Intro Voice Response Application

#### **Group Coverage**

All voice mail subscribers who receive call answer coverage from Intuity AUDIX are organized into a coverage group. The coverage group is defined on the Group Coverage form (Form 7c for Release 3.0; Form 6d for Release 2.0). The easiest place to get the subscriber extensions is from Form 2a, System Numbering — Station Jacks.

To set up the group coverage, use the Group Coverage form (Form 7c for Release 3.0; Form 6d for Release 2.0) and follow these steps:

- 1. At the top of the form, write **30/AUDIX** as the group number. The default group number is 30, but this may be changed if necessary.
- 2. In the "Extension Nos." area, list the extension of each subscriber. Subscribers should be marked on Form 2a by a check mark in the "AUDIX Voice Power" column. There is no limit to the number of extensions that can be included in a coverage group. If there is not enough room on the form, improvise by joining it to the next group on the form.
- 3. In the "Receivers" area, check "Calling Group." The actual calling group is defined later.
- 4. For Release 2.0, in the "Group Coverage" section on each copy of Forms 4b, 4d, 5a, and 5b, check "Yes" and write in the coverage group number (default 30).



For Release 3.0, Group Coverage is specified on Form 7c only.

5. For MERLIN LEGEND system, Release 3.0, you can program a button for Direct Voice Mail (DVM) on individual sets using Forms 4b, 4d, 5a, and 5b.

## **Group Calling**

As discussed under "Port Considerations" in Chapter 1, you must have at least one calling group and possibly several calling groups that contain the voice ports that connect the MERLIN LEGEND system to the Intuity system. Each calling group is defined on a copy of the Group Calling form (Form 7d for Release 3.0; Form 6e for Release 2.0). To define each calling group, follow these steps:

- 1. At the top of page 1 on the Group Calling form (Form 7d for Release 3.0; Form 6e for Release 2.0), define the group number, a group name, and the factory-set number for the group. Typically, the 770 group is assigned to the voice mail system.
- 2. Under "Extensions," list the extension number of each voice port that connects to the Intuity system. A maximum of 20 voice ports can be listed.
- 3. Under "Trunks/Pools," list each trunk that sends calls into the group. Include trunks used for automated attendants, bulletin boards, and Intuity IVR applications.
- 4. On page 2, under "Hunt Type," check "Linear."
- 5. Under "Group Type" check "Integrated VMI" for all groups that are not exclusively dedicated to Intuity IVR applications. The group that includes Intuity AUDIX must be "Integrated VMI." For groups that are exclusively dedicated to Intuity IVR applications, check "Generic VMI."

6. For Release 3.0, in the "Provide coverage for Coverage Group Numbers" section at the top of page 1, enter the coverage group number from Form 7c.

For Release 2.0, under "Coverage Group Receiver," check "Yes," and enter the coverage group number from Form 6d.

7. Use the default settings for the remaining options on page 2 of the Group Calling form (Form 7d for Release 3.0; Form 6e for Release 2.0).

# **Restrictions and Allowed and Disallowed Lists**

To prevent toll fraud, all extensions used for voice ports should be restricted at the highest practical level. The actual level of restriction depends on whether outcalling and AMIS networking are in use. The following restrictions can be placed upon individual extensions as necessary to provide security:

- Outward restriction prevents outside calls from being made except those on an allowed list.
- Toll restriction prevents calls from being made outside the home area code except those on an allowed list.
- Up to 8 allowed lists of up to 10 numbers each can be defined to allow otherwise restricted extensions to make specific calls. Each allowed list entry consists of an area code and/or exchange.
- Up to 8 disallowed lists of up to 10 numbers each can be defined to prevent extensions from making specific calls. Each disallowed list entry consists of up to 11 digits including "wild card" digits.

One way of restricting outcalling on voice ports is to specify outward restriction with an allowed list. Each entry on an allowed list can be restricted to an area code and/or exchange.

For AMIS networking on voice ports, use outward restriction with an allowed list that is highly specific to the other switches that will be called.

Allowed Lists are defined on the Allowed Lists form (Form 6e for Release 3.0; Form 6g for Release 2.0). Disallowed Lists are defined on the Disallowed Lists form (Form 6f for Release 3.0; Form 6h for Release 2.0). You may also need to refer to the Call Restriction Assignments and Lists form (Form 6g for Release 3.0; Form 6i for Release 2.0), Forms 5c and 5d, and individual telephone forms 4b, 4d, 4e, 4f, 5a, 5b, and 5c.

#### **Night Service**

If you want to deploy automated attendant service in primary mode during the day and night, you do not have to complete the Night Service - Group Assignment form (Form 9a for Release 3.0; Form 7a for Release 2.0).

If you want to deploy automated attendant service in secondary mode during the day and primary mode during the night, complete the Night Service: Group Assignment form (Form 9a for Release 3.0; Form 7a for Release 2.0) by specifying the operator extension number (for example, 100) and the Intuity calling group (for example, 770).

# **Intuity System Integration Planning**

To plan for the Intuity system side of the integration with respect to items that are specific to the MERLIN LEGEND system, complete the following Intuity system planning forms:

- Digits in Dial Plan (Worksheet A)
- System Features (Worksheet Intuity AUDIX System Parameters Features: Transfer Considerations)

The following items are also discussed in this book because they are new features of particular interest to the integration with the MERLIN LEGEND system, but they are not unique to that switch.

- Channel Information for Installation (Worksheet Channel Information for Installation)
- Assign Service to Called Number (Worksheet Services for Assign Services to Called Number)
- Routing Table (Worksheet B)
- Business Schedules (Worksheet C)
- Holiday Schedules (Worksheet D)

# **NOTE:**

Worksheets *Channel Information for Installation* and *Services for Assign Services to Called Number* are numbered in the order that the information must be entered into the Intuity system. They are discussed in reverse order because it makes the explanation easier. Worksheets A, B, C, and D are provided in this book. Worksheets *Intuity AUDIX System Parameters Features: Transfer Considerations, Channel Information for Installation,* and *Services for Assign Services to Channel* are in *Intuity New System Planning for Release 3.0,* Chapter 10.

All other aspects of Intuity system planning are not specifically related to the MERLIN LEGEND system and are covered in other Release 2.0 documentation.

### **Digits in Dial Plan**

The Intuity system requires a fixed length dial plan. You can use either a 3-digit or 4-digit dial plan as discussed in "Number Plan" on page 2-2. Write the number of digits on Worksheet A.

#### **System Features**

The Intuity system features required for the MERLIN LEGEND system are recorded in Worksheet Intuity AUDIX System Parameters Features: Transfer Considerations in Intuity New System Planning for Release 3.0. The following parameters should be set:

Transfer Type = basic

Transfer Restriction = subscribers

Covering Extension = system console or operator extension

### **Channel Information for Installation**

For Intuity to operate properly, it must know what extension has been assigned to each of its channels (voice ports) and how incoming calls on that channel are to be processed. Worksheet *Channel Information for Installation* in *Intuity New System Planning for Release 3.0* provides columns for "Channel Number," "Extension," "Initial Service," and "Optional Dedicated Service."

For each channel, you must fill in the extension number.

All channels that are part of an *integrated VMI* calling group should be assigned DNIS\_SVC.

For those channels dedicated to a specific Intuity IVR application, defined in a *separate* generic VMI calling group, write the application name in the "Optional Dedicated Service" column.

#### **Assign Service to Called Number**

All calls not assigned to a specific Intuity IVR application directly are processed by the \*DNIS\_SVC. In order for \*DNIS\_SVC to function with both Intuity AUDIX and Intuity IVR applications defined in a shared port group, the installer must fill out a table in the system that will tell the DNIS\_SVC which called number should receive a particular service. Worksheet *Services for Assign Service to Called Number* in *Intuity New System Planning for Release 3.0* provides a "Service Name" column and a "Called Number" column. The worksheet should contain an initial entry with **AUDIX** in the "Service Name" column and **ANY** in the "Called Number" column.

Any additional entries in the table are used to associate specific called numbers with Intuity IVR applications. Calls not specifically routed elsewhere are routed to Intuity AUDIX where the called number is next processed through the Routing Table.

#### **Routing Table**

The Routing Table is created from "Worksheet B: Routing Table." There are a maximum of 25 rows in the routing table. This worksheet has the following columns:

Incoming Called Number

This column contains a called number or a range of called numbers (separated by a dash). The called number on an incoming call is compared to this column. If no match is found, it is passed directly to Intuity AUDIX without changing the called number. If a match is found, the remaining columns are examined for processing.



On the MERLIN LEGEND system, any trunk that rings directly into a calling group will deliver the "Trunk ID" (8nn) as the called number.

Business Schedule

This column contains either the specific tag "login," the name or number of one of the four possible business schedules, or is blank.



Both the Business Schedule column and the Holiday Schedule column cannot be blank.

If the specific tag "login" is found, the call information is altered so that the caller will receive Voice Mail service, and the call is passed to Intuity AUDIX.

If a business schedule is specified (and the current date was not already found in the specified holiday schedule), the specified business schedule is examined to determine if the current time falls within the alternate hours for the current day of week. If a match is found, the automated attendant mailbox in the "Alternate Service Mailbox" column is substituted for the called number, and the call is passed to Intuity AUDIX.

If a match to the alternate hours is not found, the specified business schedule is examined to see if it follows the switch night service status. If so, the automated attendant mailbox in the "Day Service Mailbox" or "Night Service Mailbox" column, depending on the switch night service status, is substituted for the called number, and the call is passed to Intuity AUDIX.

If the business schedule does not follow the switch night service status, the day service hours are examined for the current day of week. If a match is found, the automated attendant mailbox in the "Day Service Mailbox" column is substituted for the called number, and the call is passed to Intuity AUDIX. Otherwise, the automated attendant mailbox in the "Night Service Mailbox" column is substituted for the called number, and the call is passed to Intuity AUDIX.

Holiday Schedule

This column contains the name or number of one of the four possible holiday schedules or is blank.



Both the Business Schedule column and the Holiday Schedule column cannot be blank.

After checking the "Business Schedule" column for the specific tag "login," any specified holiday schedule is checked for an entry for the current date. If a matching date is found, the automated attendant mailbox from the "Mailbox" column of the specified holiday schedule is substituted for the called number, and the call is passed to Intuity AUDIX. If no match is found, the business schedule (if any) is checked.

Day Service Mailbox

This column contains the automated attendant mailbox to be substituted for the called number if a match is found in the business schedule for day service hours. This matching is performed after checking for a match on alternate service hours.

Night Service Mailbox

This column contains the automated attendant mailbox to be substituted for the called number if a no match is found in the business schedule for day service hours. This matching is performed after checking for a match on alternate service hours.

Alternate Service Mailbox

This column contains the automated attendant mailbox to be substituted for the called number if a match is found in the business schedule for alternate service hours.

 $\blacksquare$  NOTE:

The mailboxes that are specified in the routing table and holiday schedules typically do not correspond to extensions on the telephone system. They are defined as automated attendant main menus.



The mailboxes that are specified in the routing table and holiday schedules must be administered on the Intuity system before the routing table and holiday schedules can be administered.

#### **Business Schedules**

A business schedule allows a business to specify different automated attendant service based on its normal hours (day service range) and, if needed, an alternate service range (for example, lunch break). If the business prefers, it can allow its day or night service to follow the switch night service status.

There can be a maximum of four business schedules. Each business schedule is associated with specific called numbers (which may be trunk numbers). Each business schedule is created from Worksheet C: Business Schedule. This worksheet has the following fields and columns:

Business Schedule

This field contains the name of the business schedule. Default names are "busn" where "n" is 1, 2, 3, or 4. The business schedule can be referred to in the Routing Table by either its name or number. The specific tag "login" is reserved and cannot be used as the name of a business schedule.

Follow Night Service Status?

If this field contains "n," a match is made against day service hours for the day of week to determine whether day service or night service should be provided.

If this field contains "y," the day service hours must be blank. Night service is provided based on the switch night service status.



In either case, a match for the alternate service hours for the day of week is performed first.

Day of Week

This column lists the seven days of the week. It cannot be changed.

Day Service Hours (Start Time and End Time)

This pair of columns lists the start and end times for day service on the specified day of week. Use 24-hour time (00:00 to 23:59) to specify start and end times. The end time must be later than the start time. For night service only, leave the columns blank. For day service only, specify start time as 00:00 and end time as 23:59.

Alternate Service Hours (Start Time and End Time)

This pair of columns lists the start and end times for alternate service on the specified day of week. Use 24-hour time (00:00 to 23:59) to specify start and end times. The end time must be later than the start time.

#### **Holiday Schedules**

A holiday schedule allows a business to specify appropriate greetings and automated attendant service based on holidays.

There can be a maximum of four holiday schedules, each with up to 26 holidays. Each holiday schedule is associated with specific called numbers (which may be trunk numbers). Each holiday schedule is created from "Worksheet D: Holiday Schedule." This worksheet has the following fields and columns:

Holiday Schedule

This field contains the name of the holiday schedule. Default names are "holn" where "n" is 1, 2, 3, or 4. The holiday schedule can be referred to in the Routing Table by either its name or number.

Holiday Name

This column contains the name of the holiday. It is used only for documentation.

Date

This column contains the date (mm/dd) to be used for matching.

Mailbox

This column contains the automated attendant mailbox to be substituted for the called number if a match is found in the "Date" column. This mailbox does not need to correspond to an extension on the switch.

# **Implementing the Integration**

# 3

This chapter explains how to implement the integration between the MERLIN LEGEND system and the Intuity system. It includes all steps necessary to get the system up and running for both acceptance testing and cut-to-service.

# Hardware Platform Installation

Before beginning any other task, complete the hardware installation checklist in Chapter 1 of the appropriate document for the hardware platform you are using:

- Intuity MAP/5 Installation Checklist, 585-310-154
- Intuity MAP/40 Installation Checklist, 585-310-155
- Intuity MAP/100 Installation Checklist, 585-310-156

The hardware installation checklist will refer you to the appropriate sections in the hardware installation document for the hardware platform you are using.

If you have not performed the tasks in the installation documents, complete the tasks now.

# **Hardware Platform Connection**

When the basic hardware installation tasks are complete, use the information in Chapter 4 of this document to connect the hardware platform to the MERLIN LEGEND system and to any adjunct equipment.

# **Completing the Software Installation**

All basic software is installed at the factory before shipment. To complete the software installation and customize the system, refer to the software installation checklist in Chapter 2 of the *Intuity Installation Checklist*, 585-310-161.

Complete the Intuity software installation checklist up to, but not including, the task "Administer the Switch."

The software installation checklist refers you to the appropriate sections in *Intuity Software Installation for Release 3.0,* 585-310-160.

# MERLIN LEGEND Initial Administration

Before the MERLIN LEGEND system and the Intuity system can communicate, you must perform basic initial administration on the MERLIN LEGEND system.

# **NOTE:**

These procedures correspond to the step "Administer the Switch" in Chapter 2 of the appropriate *Intuity Installation Checklist*.

The following procedures should be performed before proceeding with the remainder of the Intuity system software configuration or the initial Intuity system administration:

1. Renumber the MERLIN LEGEND system for a consistent 3-digit or 4-digit dial plan. Use the renumbering information on Forms 2a, 2b, 2c, and 2d that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book. The MERLIN LEGEND system programming procedure is described in Chapter 5, "MERLIN LEGEND Switch Administration".

2. Assign an integrated VMI calling group with linear hunt type, as defined on the Group Calling form (Form 7d for Release 3.0; Form 6e for Release 2.0) that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book. The MERLIN LEGEND system programming procedure is described in Chapter 5, "MERLIN LEGEND Switch Administration" in this book.

# **NOTE**:

Do not assign the trunks to the integrated VMI calling group at this time. Do not set the integrated VMI calling group as the receiver for the coverage group at this time. The Intuity system is not set up to handle the calls yet, and callers will not receive the correct service.

 Assign the Tip/Ring voice ports to the integrated VMI calling group defined on the Group Calling form (Form 7d for Release 3.0; Form 6e for Release 2.0) that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book. The MERLIN LEGEND system programming procedure is described in Chapter 5, "MERLIN LEGEND Switch Administration" in this book.

# **Intuity System Initial Administration**

Before the Intuity system and the MERLIN LEGEND system can communicate, you must perform basic initial administration on the Intuity system.



These procedures correspond to the following steps in Chapter 2 of the appropriate *Intuity Installation Checklist*.

- Administer the Intuity Switch Interface on Intuity See Step 1.
- Map Channels to Switch Extensions See checklist. Use the extension and service information on Worksheet Channel Information for Installation that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book.
- Verify Channel State See checklist.
- Assign Service to Channels for Testing See checklist.
- Test Each Channel See checklist.
- Assign Services to Called Numbers See Step 2.
- Map Services to Channels for Operation See Step 3.
- Administer Intuity AUDIX Parameters and Basic Features See Step 4.

The following procedures should be performed before proceeding with the remainder of the Intuity system software installation:

- Stop the voice system, set the number of digits in the dial plan, and restart the voice system. Use the number of digits information on Worksheet A that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book. The Intuity system programming procedure is described in the "Set number of Digits in Dial Plan" section of Chapter 6, "Intuity System Administration" in this book.
- 2. Administer the assigned service to called number information. Use the service and called number information on Worksheet *Services for Assign Services to Called Number* that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book. The Intuity system programming procedure is described in the "Assign Services to Called Numbers" section of Chapter 3, "Initial Platform Administration and Test" in *Intuity Software Installation for Release 3.0*, 585-310-160.
- 3. Administer channel information for installation. Use the extension and service information on Worksheet *Channel Information for Installation* that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book. The Intuity system programming procedure is described in the "Map Services to Channels for Operation" section of Chapter 3, "Initial Platform Administration and Test" in *Intuity Software Installation for Release 3.0*, 585-310-160.
- 4. Set the system parameters required for MERLIN LEGEND system. Use the parameter information on Worksheet Intuity AUDIX System Parameters Features: Transfer Considerations that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book. The Intuity system programming procedure is described in the "Administer Intuity AUDIX Parameters and Basic Features" section of Chapter 4, "Intuity AUDIX Administration and Test" in Intuity Software Installation for Release 3.0, 585-310-160.

#### **Perform Acceptance Testing**

For acceptance testing, you must perform administration on both the MERLIN LEGEND system and the Intuity system. Then, you make test calls to check functionality. The major difference between acceptance testing and cut-to-service is the smaller number of subscribers and the more limited functionality tested.

## **NOTE:**

These procedures correspond to the following steps in Chapter 2 of the appropriate *Intuity MAP/n Installation Checklist*.

- Add Test Subscribers 1 and 2
- Test Call Answer and Voice Mail
- Remove Test Subscribers 1 and 3

You must perform the following tasks to administer a MERLIN LEGEND switch for acceptance tests:

 Select two subscribers from among the stations listed on Form 2a as having Intuity AUDIX call coverage and defined by Forms 4b, 4d, 5a, or 5b. If you are working during business hours, request that the MERLIN LEGEND System Administrator select the subscribers so that business will not be disturbed.

Use the MERLIN LEGEND system programming procedure described in Chapter 5, "MERLIN LEGEND Switch Administration" in this book to add the extensions of the selected subscribers to the coverage group. The coverage group was defined on the Group Coverage form (Form 7c for Release 3.0; Form 6d for Release 2.0) that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book.

2. Select the same two subscribers from among those defined on the Intuity system using Worksheet *Intuity AUDIX Subscriber Administration* that you filled out in Chapter 2 of *Intuity New System Planning for Release 3.0.* 

Add the selected subscribers to the Intuity system. Use the Intuity system add subscriber procedure described in Chapter 10, "INTUITY AUDIX Cut-to-Service Procedures" of *Intuity Software Installation for Release 3.0*.

- 3. Connect the coverage group to the integrated VMI calling group by using the programming procedure described in Chapter 5, "MERLIN LEGEND Switch Administration" in this book. The calling group was defined on the Group Calling form (Form 7d for Release 3.0; Form 6e for Release 2.0) that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book.
- 4. Make test calls to each subscriber, but do not answer the calls. The Intuity system should provide call answer service for these calls.

5. While listening to the first subscriber's greeting, enter \*, 3, the other subscriber's extension, and #.

Verify that the call is transferred to the second subscriber.

6. Make test calls directly from the subscriber stations to the calling group. The Intuity system should provide voice mail service for these calls.

# Administer and Test Optional Intuity Packages

Return to the Software Installation Checklist, Chapter 2 at the step marked "Test Intuity AUDIX Multilingual feature."

Continue with the software installation checklist up to the step marked "Administer Switch for Cut-to-Service."

#### **NOTE:**

This section of the Software Installation Checklist includes administration of the Intuity AUDIX subscribers, outcalling, automated attendant menus, greetings, etc.

# Administer Automated Attendant Enhancements

Before final switch administration, enter the Routing Table, Business Schedules and Holiday Schedules defined on Worksheets B, C, and D.

#### **NOTE:**

The business schedules and holiday schedules must be entered before they can be referenced in the routing table. Therefore, the routing table must be entered last.

- Enter the Business Schedules using the information on Worksheet C that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book. The Intuity system programming procedure is described in the "Entering the Business Schedules" section of Chapter 6, "Intuity System Administration" in this book.
- 2. Enter the Holiday Schedules using the information on Worksheet D that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book. The Intuity system programming procedure is described in the "Entering the Holiday Schedules" section of Chapter 6, "Intuity System Administration" in this book.

3. Enter the Routing Table using the information on Worksheet B that you filled out following the instructions in Chapter 2, "Planning the Integration". The Intuity system programming procedure is described in the "Entering the Routing Table" section of Chapter 6, "Intuity System Administration" in this book.

# Administer MERLIN LEGEND System for Cut-to-Service

At this time, the Intuity system is ready to process calls. The final administration steps on the MERLIN LEGEND system route those calls through the voice ports to the Intuity system. Perform the following steps to cut-to-service:

1. Use the MERLIN LEGEND system programming procedure described in Chapter 5, "MERLIN LEGEND Switch Administration" in this book to add the extensions of the remaining subscribers to the coverage group. The coverage group was defined on the Group Coverage form (Form 7c for Release 3.0; Form 6d for Release 2.0) that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book.

# **NOTE:**

The coverage group was connected to the integrated VMI calling group as part of the acceptance test procedure.

2. Use the MERLIN LEGEND system programming procedure described in Chapter 5, "MERLIN LEGEND Switch Administration" in this book to direct incoming calls on specified trunks to the calling group(s). The calling group was defined on the Group Calling form (Form 7d for Release 3.0; Form 6e for Release 2.0) that you filled out following the instructions in Chapter 2, "Planning the Integration" in this book.

The integration is now complete with the exception of networking.

# **Administer Networking**

If your system includes analog (AMIS) or digital networking, return to the Software Installation Checklist, Chapter 2, to the step marked "Administer Analog Networking."

Continue to the end of the software installation checklist.

# Connectivity

# 4

This chapter contains information that describes the hardware components and connections involved in connecting an Intuity system and a MERLIN LEGEND system:

- Configuration descriptions that explain each of the components required to establish a link between the Intuity system and the switch or other adjuncts.
- Wiring diagrams that show you the different hardware, physical connections, and cables used to connect the Intuity system, the switch, and other adjuncts.

Read the information in this chapter to understand the basic requirements of connecting the Intuity system, switch, and adjuncts *before* you attempt to connect the components.

# MERLIN LEGEND Voice Port Requirements

The Intuity system voice ports must be connected to tip/ring ports on a Basic Telephone Module (BTM-012). The MERLIN LEGEND system must contain a ring generator for ringing the BTM ports on *each carrier* that has a BTM board.

There are two limitations on the number of Intuity voice ports that can be connected to the same BTM:

Ring Blocking

A maximum of four ports on a BTM can be rung at any one time. Due to this limitation, a maximum of eight ports on a BTM can be used for Intuity voice ports.

Touch-Tone Receivers (TTR)

Two TTRs are provided on each BTM. Unless additional TTRs are available, a maximum of four ports on a BTM can be used for Intuity voice ports. Additional TTRs are provided on 400 GS/LS/TTR, 400 LS/TTR and other circuit modules. Approximately one TTR is required for each two Intuity voice ports, but the level of system activity may make TTRs on other circuit modules unavailable for Intuity voice port use. Consult the MERLIN LEGEND Communication System documentation for more details.

As a general rule, use a separate BTM board for every four ports unless additional Touch-Tone receivers are available. Use a maximum of eight ports when additional Touch-Tone receivers are available.

Unused BTM ports may be used for single-line sets (SLS), fax machines, modems, and phantom stations (an assigned extension with no physical telephone set). The limitation is based on the number of ports that may require ringing at the same time. *All* unused ports can be used for devices *that will never ring*. The recommendations in Table 4-1 should be followed for devices that may ring.

Use the information and diagrams in this section to connect or verify the connections for the Intuity system with a MERLIN LEGEND switch.

# **IVC6** Connections

There are two methods commonly used to connect IVC6 boards:

- Using an 885A adapter to connect to RJ11C connections
- Connecting to a type 104B connecting block

# Connect IVC6 Boards Using 885A Adapter:

Connect IVC6 boards using an 885A adapter as follows:

- 1. Make sure that the line pairs were run individually (RJ11C).
- 2. Use a type 885A adapter to consolidate the six individual line pairs into three pairs in each of two cables. (See Figure 4-1.)
- 3. There is an adhesive strip on the back of the 885A adapter. Remove the protective coating paper, and attach the 885A adapter in a convenient place.
- 4. Use the supplied 6-conductor modular cables between the IVC6 board and the adapter.
- 5. Use the supplied 2- or 4- conductor modular cables between the adapter and the RJ11C modular jacks.
- 6. Label the connections in the space provided on the 885A adapter.

# **NOTE:**

The label on the 885A adapter refers to an IVP6. This should be interpreted as an IVC6.

# Connect IVC6 Boards Using 104A Connecting Blocks:

Connect IVC6 boards using type 104A connecting blocks as follows:

- 1. Make sure that the line pairs were run together to type 104A connecting blocks or equivalent. (See Figure 4-2.)
- 2. Use the supplied D6AM 6-conductor modular cables between the IVC6 board and the type 104A connecting block.

# **NOTE:**

This is one of many ways to connect IVC6 boards to the MERLIN LEGEND system using inside building wire. It is subject to the same distance limitations as stations. The key element is the connection of the T/R circuits to the correct pins on the connecting block jacks.

# **Connecting Serial Ports**

The Intuity system communicates with various devices through serial ports. Serial ports are required for:

- MERLIN LEGEND administration
- Optional Remote Maintenance Modem
- Optional Call Accounting System
- Optional customer administration terminal(s)

Only MERLIN LEGEND administration and the Remote Maintenance Modem are constrained to specific ports. Any other connections are made to available ports. There are two built-in ports on the Intuity system processors. If three or more devices are required, a Multi-Port Serial Card must be included in the configuration.

- Built-in Serial Port 1 (COM1, tty00) is used for administering the MERLIN LEGEND system.
- Built-in Serial Port 2 (COM2, tty01) is used for the second device. If the Remote Maintenance Modem is present, it must be connected to this port.

- Add-on serial ports (ttyaa through ttyah) on a Multi-Port Serial Card are used for the third and subsequent device.
- The preferred order of connection of the devices is:
  - MERLIN LEGEND administration
  - optional Remote Maintenance Modem
  - optional Call Accounting System (SMDR)
  - optional customer remote access terminals or modems

If the MERLIN LEGEND system is within 50 feet (15 meters) of the Intuity system, and the MERLIN LEGEND system and the Intuity system share the same power outlet, a direct connection can be made between the MERLIN LEGEND administration and optional SMDR ports and the Intuity system ports.

If the MERLIN LEGEND system is farther than 50 feet (15 meters) from the Intuity system, or the MERLIN LEGEND system and the Intuity system do not share the same power outlet, data cables from the MERLIN LEGEND system administration and optional SMDR ports to the Intuity system ports have to be extended with Z3A2 ADU cable drivers. Two Z3A2 ADU interface units are required for each cable, one at each end.

The optional Remote Maintenance Modem must be co-located with the Intuity system processor and must be connected to Serial Port 2.

Optional customer access terminals may be co-located with the Intuity system processor and directly connected to the next available serial port, or one or more modems may be connected to the next available serial port(s) for dial-in access.

## **Connecting Administration Ports** Within 50 feet, Same Power Outlet

This method is used only when the MERLIN LEGEND Communications System and the Intuity system are within 50 feet and share the same power outlet.

The following parts are required:

- DB-9S to DB-25P Adapter (MAP/40 and MAP/100 only)
- 355AF Adapter
- D8W-87 Modular Cord

Refer to Figure 4-3. Connect the MERLIN LEGEND Communications System Admin port and the Intuity system Serial Port 1 (COM1) by following these steps:

- 1. Connect one end of a D8W-87 modular cord to the Admin (lower) jack of the MERLIN LEGEND Communications System.
- 2. Connect the other end of the D8W-87 modular cord to a 355AF adapter.

- 3. Connect to the Intuity system:
  - For the MAP/5, connect the 355AF adapter directly to Serial Port 1 (tty00) of the MAP/5.
  - For the MAP/40 and MAP/100, connect the 355AF adapter to the 25-pin end of the DB-9S to DB-25P adapter and then connect the 9pin end of that adapter to port COM1 (tty00) of the MAP/40 or MAP/100.

# Connect Admin Ports More Than 50 feet/Different Power Outlet

This method is used only when the MERLIN LEGEND Communications System and the Intuity system are more than 50 feet apart or do not share the same power outlet.

# **NOTE:**

The MERLIN LEGEND system does not support out of building operation of the Intuity system.

The following parts are required:

- DB-9S to DB-25P Adapter (MAP/40 and MAP/100 only)
- 355AF Adapter
- Three D8W-87 Modular Cords

- M7-U87 Crossover Cable
- Two (2) Z3A2 ADUs
- Two M8AJ-87 Cables
- D8AM-87 Modular Crossover Cable
- Two (2) 400B2 Adapters
- Two (2) D6AP-87 Modular Cords
- Two (2) 248B Adapters
- Two (2) 2012D Power Transformers

#### **NOTE:**

The combination of a Z3A2 ADU and a M8AJ-87 cable is equivalent to a Z3A4 ADU. You must order both pieces (one of each).

### $\blacksquare$ NOTE:

Inside wire must be 4-pair, suitable for data; type 3 UTP data cable or better.

Refer to Figure 4-4. Connect the MERLIN LEGEND Communications System Admin port and the Intuity system Serial Port 1 (COM1) by following these steps:

- 1. Connect one end of a D8W-87 modular cord to the Admin (lower) modular jack on the MERLIN LEGEND Communications System.
- 2. Connect the other end of the D8W-87 modular cord to a 355AF adapter.
- 3. Connect the 355AF adapter to one end of an M7-U87 crossover cable.
- 4. Connect the other end of the M7-U87 crossover cable to the matching end of a M8AJ-87 cable.
- 5. Connect the other end of the M8AJ-87 cable to the matching connector on a Z3A2 ADU.
- 6. Connect one end of a D8W-87 modular cord to the modular jack marked **WALL** on the Z3A2 ADU.
- 7. Connect the other end of the D8W-87 modular cord to the modular jack end of a D8AM-87 crossover cord.
- 8. Connect the modular plug end of the D8AM-87 crossover cord to the matching modular jack on a 400B2 adapter.
- 9. Plug the 400B2 adapter into the wall jack leading to the Intuity system site.
- 10. Connect one end of a D6AP-87 modular cord to the 400B2 adapter.
- 11. Mount a 248B adapter to a 2012D power transformer.
- 12. Connect the other end of the D6AP-87 modular cord to the 248B adapter.
- 13. Plug the 2012D power transformer into an AC power outlet.




Go to the Intuity system site to continue the connection. Refer to Figure 4-5.

- 14. Connect to the Intuity system:
  - For the MAP/5, connect one end of a M8AJ-87 cable directly to Serial Port 1 (tty00) of the MAP/5.
  - For the MAP/40 and MAP/100, connect one end of a M8AJ-87 cable to the 25-pin end of the DB-9S to DB-25P adapter, and then connect the 9-pin end of that adapter to port COM1 (tty00) of the MAP/40 or MAP/100.
- 15. Connect the other end of the M8AJ-87 cable to the Z3A2 ADU.
- 16. Connect one end of a D8W-87 modular cord to the modular jack marked **WALL** on the Z3A2 ADU.
- 17. Connect the other end of the D8W-87 modular cord to a 400B2 adapter.
- Plug the 400B2 adapter into the wall jack from the Communications System site.
- 19. Connect one end of a D6AP-87 cord to the 400B2 adapter.

- 20. Mount a 248B adapter on a 2012D power transformer.
- 21. Connect the other end of the D6AP-87 cord to the 248B adapter.
- 22. Plug the 2012D power transformer into an AC outlet.

#### Connecting SMDR Ports Within 50 feet, Same Power Outlet

This method is used only when the MERLIN LEGEND Communications System and the Intuity system are within 50 feet and share the same power outlet.

The following parts are required:

- For connection to Serial Port 2 (MAP/5) or COM2 (MAP/40 and MAP/100):
  - DB-9S to DB-25P Adapter
  - 355AF Adapter
  - Z200A EMI Filter Modular Cord
- For connection to first available port on the Multi-Port Serial Card:
  - Multi-Port Serial Card (if not already installed)
  - 6 position, 6 conductor straight-through modular cord (supplied with Multi-Port Serial Card)
  - DTE 4/6-to-DB-25P Adapter (supplied with Multi-Port Serial Card)

**NOTE:** 

This adapter has slanted sides as shown in the figure.

- 355AF Adapter
- Z200A EMI Filter Modular Cord

Connect to Serial Port 2 (COM2) if it is available and if it is not reserved for use by a Remote Maintenance Modem. If Serial Port 2 (COM2) is not available, connect to the first available port on the Multi-Port Serial Card.

#### **Connecting to Serial Port 2 (COM2)**

To connect to Serial Port 2 (COM2), refer to Figure 4-6. Connect the MERLIN LEGEND Communications System SMDR port and the Intuity system port by following these steps:

- 1. Connect the short end of the Z200A EMI Filter modular cord to the SMDR (upper) jack of the MERLIN LEGEND Communications System.
- 2. Connect the long end of the Z200A EMI Filter modular cord to a 355AF adapter.

- 3. Connect the 355AF adapter to the matching connector of a 9-pin-to-25-pin adapter.
- 4. Connect the other end of the 9-pin-to-25-pin adapter to the Serial Port 2 (MAP/5) or COM2 (MAP/40 and MAP/100) of the Intuity system.

## Connecting to First Available Serial Port on Multi-Port Serial Card

To connect to the first available port on the Multi-Port Serial Card, refer to Figure 4-7. Connect the MERLIN LEGEND Communications System SMDR port and the Intuity system port by following these steps:

- 1. Connect the short end of the Z200A EMI Filter modular cord to the SMDR (upper) jack of the MERLIN LEGEND Communications System.
- 2. Connect the long end of the Z200A EMI Filter modular cord to a 355A adapter.
- 3. Connect the 355A adapter to the 25-pin side of the DTE 4/6-to-DB 25P adapter.
- 4. Connect one end of the 6-position, 6-conductor modular cord to the DTE 4/6-to-DB 25P adapter.
- 5. Connect the other end of the modular cord to the first available port on the Multi-Port Serial Card.

#### **Connecting SMDR Ports More Than 50 feet/Different Power Outlet**

This method is used only when the MERLIN LEGEND Communications System and the Intuity system are more than 50 feet apart or do not share the same power outlet.

#### **NOTE:**

The MERLIN LEGEND system does not support out of building operation of the Intuity system.

The following parts are required for connection to Serial Port 2 or COM2:

 DB-9S to DB-25P Adapter (for connection to Serial Port 2 on MAP/5 or COM2 on MAP/40 or MAP/100 only) The following parts are required for connection to the Multi-Port Serical Card:

- Multi-Port Serial Card (if needed and not already installed)
- 6 position, 6 conductor straight-through modular cord (for connection to Multi-Port Serial Card only, supplied with Multi-Port Serial Card)
- DTE 4/6-to-DB-25P Adapter (for connection to Multi-Port Serial Card only, supplied with Multi-Port Serial Card)



This adapter has slanted sides as shown in Figure 4-9.

The following parts are required for either type of connection:

- 355AF Adapter
- Z200A EMI Filter Modular Cord
- Two D8W-87 Modular Cords
- M7-U87 Crossover Cable
- Two Z3A2 ADUs
- Two M8AJ-87 Cable
- D8AM-87 Modular Crossover Cable
- Two 400B2 Adapters
- Two D6AP-87 Modular Cords
- Two 248B Adapters
- Two 2012D Power Transformers

#### **NOTE:**

The combination of a Z3A2 ADU and a M8AJ-87 cable is equivalent to a Z3A4 ADU. You must order both pieces (one of each for Admin port, another of each for SMDR port).

#### $\blacksquare$ NOTE:

Inside wire must be 4-pair, suitable for data; type 3 UTP data cable or better.

Connect to Serial Port 2 (COM2) if it is available and if it is not reserved for use by a Remote Maintenance Modem. If Serial Port 2 (COM2) is not available, connect to the first available port on the Multi-Port Serial Card.

Refer to Figure 4-8. Connect the MERLIN LEGEND Communications System SMDR port and the Intuity system by following these steps:

- 1. Connect the short end of the Z200A EMI filter modular cord to the SMDR (upper) modular jack on the MERLIN LEGEND Communications System.
- 2. Connect the long end of the D8W-87 modular cord to a 355AF adapter.

- 3. Connect the 355AF adapter to one end of an M7-U87 crossover cable.
- 4. Connect the other end of the M7-U87 crossover cable to the matching end of a M8AJ-87 cable.
- 5. Connect the other end of the M8AJ-87 cable to the matching connector on a Z3A2 ADU.
- 6. Connect one end of a D8W-87 modular cord to the modular jack marked **WALL** on the Z3A2 ADU.
- 7. Connect the other end of the D8W-87 modular cord to the modular jack end of a D8AM-87 crossover cord.
- 8. Connect the modular plug end of the D8AM-87 crossover cord to the matching modular jack on a 400B2 adapter.
- 9. Plug the 400B2 adapter into the wall jack leading to the Intuity system site.
- 10. Connect one end of a D6AP-87 modular cord to the 400B2 adapter.
- 11. Mount a 248B adapter to a 2012D power transformer.
- 12. Connect the other end of the D6AP-87 modular cord to the 248B adapter.
- 13. Plug the 2012D power transformer into an AC power outlet.

- 14. Connect to the Intuity System:
  - To connect to Serial Port 2 on the MAP/5 or COM2 on the MAP/40 or MAP/100, connect the 9-pin end of the 9-pin-to-25-pin adapter to Serial Port 2 on the Intuity system. Then connect one end of an M8AJ-87 cable to the 25-pin end of the 9-pin-to-25-pin adapter.
  - To connect to the first available port on the Multi-Port Serial Card, connect one end of the 6-position, 6-conductor modular cord to the port. Connect the other end of the modular cord to the DTE 4/6-to-DB-25P Adapter. Then connect one end of an M8AJ-87 cable to the other end of the DTE 4/6-to-DB-25P adapter
- 15. Connect the other end of the M8AJ-87 cable to the Z3A2 ADU.
- 16. Connect one end of a D8W-87 modular cord to the modular jack marked **WALL** on a Z3A2 ADU.
- 17. Connect the other end of the D8W-87 modular cord to a 400B2 adapter.
- Plug the 400B2 adapter into the wall jack from the Communications System site.

- 19. Connect one end of a D6AP-87 cord to the 400B2 adapter.
- 20. Mount a 248B adapter on a 2012D power transformer.
- 21. Connect the other end of the D6AP-87 cord to the 248B adapter.
- 22. Plug the 2012D power transformer into an AC outlet.

#### Networking

Networking is an *optional* application on Intuity systems connected to the MERLIN LEGEND system. MERLIN LEGEND system supports Intuity low-speed digital networking and AMIS analog networking. High-speed digital networking is not supported since the MERLIN LEGEND system does not support the DCP protocol.

There are two methods for configuring low-speed digital networking with the MERLIN LEGEND system:

- If the MERLIN LEGEND system has DID lines, Intuity low-speed digital networking is connected through the MERLIN LEGEND switch.
- If the MERLIN LEGEND system does not have DID lines, the connections use Loop Start (LS) lines from the Central Office (CO) and bypass the switch.

AMIS Analog Networking requires no special hardware for connectivity since it uses the voice channels already assigned to voice services. (Traffic configuration rules may necessitate the addition of voice channels to absorb the load of AMIS networking.)

In order to support AMIS Analog Networking, the MERLIN LEGEND system must be configured to send incoming calls on external lines directly to AUDIX. (Touchtone codes on the incoming calls identify the calls as AMIS networking and cause proper call handling.) Many MERLIN LEGEND customers already do this in order to support an automated attendant.

#### **Connecting Low-Speeed Digital Networking**

The following parts are required:

- ACCX Board (includes cable and breakout box)
- Modem (Paradyne<sup>®</sup> COMSPHERE<sup>®</sup> 3820, includes modular cord and power supply)
- DB-25 M-M cable

Refer to Figure 4-10. Connect the Intuity low speed networking by following these steps:

- 1. Connect one end of the ACCX cable to the connector on the ACCX card.
- 2. Connect the other end of the ACCX cable to the matching connector on the break-out box.
- 3. Connect one end of the DB-25 M-M cable to the connector marked RS-232-CH1 (2, 3, or 4) on the break-out box.
- 4. Connect the other end of the DB-25 M-M cable to the matching connector on the modem.
- 5. Connect one end of the modular cord to the jack marked **DIAL** on the modem.
- 6. Depending on whether or not the MERLIN LEGEND system is equipped with DID lines:
  - If the system does *not* have DID lines, connect the other end of the modular cord to a RJ11C telephone jack wired to a Loop Start (LS) line from the CO.
  - If the system has DID lines, connect the other end of the modular cord to a MERLIN LEGEND Tip/Ring port that has an assigned DID number.

#### **NOTE:**

If building wire is used, it must be type 3 UTP or better. The distance limitation is the same as for a station.

- 7. Connect the power supply connector to the modem.
- 8. Plug in the power supply.
- 9. Turn on power for the modem.

#### **Remote Maintenance**

Remote Maintenance is an *optional* application for the MERLIN LEGEND Intuity system. While it is possible to use the "pass through" capability of the System Programming and Maintenance Utility (SPM) for remote maintenance, this usually requires operator assistance to do so. The Remote Maintenance option provides simpler operation and a higher level of service.

The Remote Maintenance Modem must be connected to Serial Port 2 (COM2). If Serial Port 2 (COM2) is already in use, you must do the following:

- 1. Move the device (if any) connected to Serial Port 2 (COM2) to the first available port on the Multi-Port Serial Card. See device specific instructions elsewhere in this chapter.
- 2. Readminister the application formerly using Serial Port 2 (COM2) to use the serial port now connected on the Multi-Port Serial Card.
- 3. Connect the Remote Maintenance Modem to Serial Port 2 (COM2).

The following parts are required:

- DB-9S to DB-25P Adapter
- RS-232 M-F cable
- Modem (Paradyne COMSPHERE 3820, includes modular cord and power supply)

Refer to Figure 4-11. Connect the Intuity Remote Maintenance Modem by following these steps:

- 1. Connect the small end of the DB-9S to DB-25P adapter to Serial Port 2 on the MAP/5 or COM2 on the MAP/40 or MAP/100.
- 2. Connect the matching end of the DB-25 M-F cable to the large end of the DB-9S to DB-25P adapter.
- 3. Connect the other end of the DB-25 M-F cable to the matching connector on the modem.
- 4. Connect one end of the modular cord supplied with the modem to the jack marked **DIAL** on the modem.
- 5. Depending on whether or not the MERLIN LEGEND system is equipped with DID lines:
  - If the system does *not* have DID lines, connect the other end of the modular cord to a RJ11C telephone jack wired to a Loop Start (LS) line from the CO.
  - If the system has DID lines, connect the other end of the modular cord to a MERLIN LEGEND Tip/Ring port that has an assigned DID number.

 $\blacksquare$  NOTE:

NOTE:

If building wire is used, it must be type 3 UTP or better. The distance limitation is the same as for a station.

- 6. Connect the power supply connector to the modem.
- 7. Plug in the power supply.
- 8. Turn on power for the modem.

#### **Remote Access**

Local Access to the Intuity system is provided by the keyboard and monitor of the Intuity system. The Multi-User Feature Package and Remote Access is an *optional* application for the MERLIN LEGEND Intuity system. It is sometimes convenient to have terminals located on the System Administrator's desk or at other locations. While it is possible to use the "pass through" capability of the MERLIN LEGEND system for remote access, this usually requires operator assistance. Remote administration allows system administrators to perform duties at their desks, saving time and trips when the Intuity system is not close by.

#### **NOTE:**

Only one user can be logged onto the Intuity system at a time unless the Multi-User Feature Package has been installed. With the Multi-User Feature, the Intuity system can accommodate up to four simultaneous logins.

Because the Multi-User Feature Package allows multiple login sessions, it is possible to delegate Intuity system administration duties to several people. This not only divides up the work needed to maintain an Intuity system but also gives subscribers and callers several points of contact should a problem occur.

#### **Dedicated Line Access**

Dedicated line access can be used when a specific terminal will always be connected to the line, that is, when dial-up access is not required. Dedicated line access is always to the first available port on the Multi-Port Serial Card. Dedicated line access can be accomplished in the following ways:

- If the terminal is within 50 feet of the Intuity system, the terminal can be connected directly to the Multi-Port Serial card using either of the methods shown in Figure 4-12.
- If the terminal is more than 50 feet from the Intuity system, it can be connected to the Multi-Port Serial card using ADUs as line extenders.

In all other cases, remote access connections (using dial-up modems) should be used.

#### **Connecting Dedicated Lines within 50 Feet**

These methods are used only when the Intuity system and the terminal are within 50 feet.

The following parts are required:

- Multi-Port Serial Card (if not already installed)
- 6-position, 6-conductor straight-through modular cord (supplied with Multi-Port Serial Card)
- DCE 4/6-to-DB-25P Adapter



This adapter has slanted sides as shown in Figure 4-12.

DB-25 M-F cable

Refer to Figure 4-12. Connect the local terminal by following these steps:

- 1. Connect one end of the 6-position, 6-conductor modular cord to the first available port on the Multi-Port Serial Card.
- 2. Connect the other end of the modular cord to the DTE 4/6-toDB-25P adapter.
- 3. Connect the matching end of the DB-25 M-F cable to the DTE 4/6-to-DB-25P adapter.
- 4. Connect the other end of the DB-25 M-F cable to the AT&T 715 terminal.

#### **Connecting Dedicated Lines beyond 50 Feet**

This method is used only when the Intuity system and the terminal are more than 50 feet apart.

If the terminal is in a building outside the main building (where the Intuity system is located), an ADU and an additional protector must be installed in each building. The ADUs and protectors provide both the Intuity system and the terminal protection against exposure to lightning, inadvertent contact with power lines, and power currents induced by nearby power lines. See the installation notes packed with the ADU for more information.

The following parts are required:

- Multi-Port Serial Card (if needed and not already installed)
- 6 position, 6 conductor straight-through modular cord (for connection to Multi-Port Serial Card only, supplied with Multi-Port Serial Card)

Inside wire must be 4-pair, suitable for data; type 3 UTP data cable or better.



Local powering of the Z3A2 ADU is optional.

Connect to the first available port on the Multi-Port Serial Card.

Refer to Figure 4-13 Connect the terminal and the Intuity system by following these steps:

- 1. Connect one end of the M7U-87 crossover cable to the terminal.
- Connect the other end of the M7U-87 cable to the matching end of a M8AJ-87 cable.

- 15. Connect the other end of the M8AJ-87 cable to the Z3A2 ADU.
- 16. Connect one end of a D8W-87 modular cord to the modular jack marked **WALL** on a Z3A2 ADU.
- 17. Connect the other end of the D8W-87 modular cord to a 400B2 adapter.
- Plug the 400B2 adapter into the wall jack from the Communications System site.
- 19. Connect one end of a D6AP-87 cord to the 400B2 adapter.
- 20. Mount a 248B adapter on a 2012D power transformer.
- 21. Connect the other end of the D6AP-87 cord to the 248B adapter.
- 22. Plug the 2012D power transformer into an AC outlet.

#### **Remote Access (Dial-Up) Connections**

Connect to Serial Port 2 (COM2) if it is available. If Serial Port 2 (COM2) is not available, connect to the first available port on the Multi-Port Serial Card.

- 6-position, 6-conductor straight-through modular cord (for connection to Multi-Port Serial Card only, supplied with Multi-Port Serial Card)
- DTE 4/6-to-DB-25P Adapter (for connection to Multi-Port Serial Card only, supplied with Multi-Port Serial Card)



This adapter has slanted sides as shown in Figure 4-15.

- DB-9S to DB-25P Adapter (for connection to Serial Port 2 on MAP/5 or COM2 on MAP/40 or MAP/100 only)
- RS-232 M-F cable (for connection to Serial Port 2 on MAP/5 or to COM2 on MAP/40 or MAP/100 only)
- Modem (Paradyne COMSPHERE 3820, includes modular cord and power supply)

Refer to Figure 4-15. Connect the Intuity Remote Maintenance Modem by following these steps:

- 1. To connect to the Intuity system:
  - To connect to Serial Port 2 (COM2), connect the small end of the DB-9P to DB-25S adapter to Serial Port 2 on the MAP/5 or COM1 on the MAP/40 or MAP/100. Then connect one end of the DB-25 M-F cable to the large end of the DB-9P to DB-25S adapter.
  - To connect to the first available port on the Multi-Port Serial Card, connect one end of the 6-position, 6-conductor modular cord to the port. Then connect the other end of the modular cord to the DTE 4/6-to-DB-25P adapter.
- 2. Connect the other end of the DB-25 M-F cable or the DTE 4/6-to-DB-25P adapter to the matching connector on the modem.
- 3. Connect one end of the modular cord supplied with the modem to the jack marked **DIAL** on the modem.

- 4. Depending on whether or not the MERLIN LEGEND system is equipped with DID lines:
  - If the system does *not* have DID lines, connect the other end of the modular cord to a RJ11C telephone jack wired to a Loop Start (LS) line from the CO.
  - If the system has DID lines, connect the other end of the modular cord to a MERLIN LEGEND Tip/Ring port that has an assigned DID number.

#### **NOTE:**

If building wire is used, it must be type 3 UTP or better. The distance limitation is the same as for a station.

- 5. Connect the power supply connector to the modem.
- 6. Plug in the power supply.
- 7. Turn on power for the modem.

# 5

This chapter describes how to administer the MERLIN LEGEND system for integration with the Intuity system. Be sure to have the MERLIN LEGEND system forms that you completed in Chapter 2.

## **Disconnect Signaling Reliability**

Use this procedure to classify the disconnect signal sent by the central office on loop-start trunks as reliable. The selected setting applies to all trunks in the system; trunks cannot be programmed individually. The disconnect signaling reliability does not apply to ground-start trunks emulated on a T1 facility.

To set the disconnect signaling reliability:

- 1. From the System Programming menu, select Lines and Trunks.
  - On the console: Select LinesTrunks.
  - On the PC: Press F4.

The Lines and Trunks menu appears.

- 2. Select Touch-Tone/Loop Start Disconnect.
  - On the console: Select TT/LS Disc.
  - On the PC: Press F3.

The TouchTone/LS Disconnect menu appears.

- 3. Select Loop Start Disconnect.
  - On the console: Select LS Disconnect.
  - On the PC: Press F2.

The LS Reliable Disconnect menu appears.

- 4. Specify the disconnect signal as reliable.
  - On the console: Select Yes.
  - On the PC: Press F1.
- 5. Save your entry.
  - On the console: Select Enter.
  - On the PC: Press F10.
- 6. Return to the System Programming menu.
  - On the console: Select Exit two times.
  - On the PC: Press F5 two times.

## **Group Coverage Member Assignments**

Use this procedure to assign a telephone to a coverage group. Coverage is an arrangement in which calls from a group of senders are redirected to one or more receivers. A coverage group is a group of senders.

 $\blacksquare$  NOTE:

This procedure assigns senders.

A maximum of 30 coverage groups is allowed, each with an unlimited number of members. Up to eight receivers can be assigned per coverage group.

A telephone can be a sender in only one group; it can be a receiver for more than one coverage group.

To assign telephones to a coverage group:

- 1. From the System Programming menu, select Extensions.
  - On the console: Select Extensions.
  - On the PC: Press F6.

The Extensions menu appears.

- 2. Access the second screen of the Extensions menu.
  - On the console: Press More.
  - On the PC: Press (PgUp).
- 3. Select Group Cover.
  - On the console: Select Group Cover.
  - On the PC: Press F3.

The Group Coverage screen appears.

- 4. Enter the coverage group number (typically, 30.)
- 5. Save your entry.
  - On the console: Select Enter.
  - On the PC: Press F10.

The Group Cover Senders screen appears.

- 6. Enter the extension number of the telephone you want to put in the coverage group.
- 7. Save your entry.
  - On the console: Select Enter.
  - On the PC: Press F10.
- 8. Repeat Steps 6 and 7 for all extensions.
- 9. Return to the System Programming menu.
  - On the console: Select Exit two times.
  - On the PC: Press F5 two times.

## **Group Calling Member Assignments**

Use this procedure to assign an 012 module port to a calling group. A calling group is used to direct calls to a group of people who all handle the same type of call. A single extension number is assigned to the group and is used by both inside and outside callers to reach the group.

A maximum of 32 calling groups with a maximum of 20 telephones per group is allowed.

To assign a port to a calling group:

- 1. Select Extensions.
  - On the console: Select Extensions.
  - On the PC: Press F6.

The Extensions menu appears.

- 2. Access the second screen of the Extensions menu.
  - On the console: Press More.
  - On the PC: Press (PgUp).
- 3. Select Group Calling.
  - On the console: Select Grp Calling.
  - On the PC: Press F4.

The Group Calling menu appears.

- 4. Select Members.
  - On the console: Select Members.
  - On the PC: Press F9.
- 5. Enter the extension number of the calling group. (Generally, use 770, unless it has been renumbered.)
- 6. Save your entry.
  - On the console: Select Enter.
  - On the PC: Press F10.
- 7. Enter the extension number of the port you want to assign.
- 8. Save your entry.
  - On the console: Select Enter.
  - On the PC: Press F10.
- 9. Repeat Steps 7 and 8 for each extension.
- 10. Return to the System Programming menu.
  - On the console: Select Exit three times.
  - On the PC: Press F5 three times.

## Group Calling Trunk or Pool Assignments

Use this procedure to assign or remove trunks or pools that ring directly into a calling group.

Incoming calls on each trunk or pool can be directed to only one calling group.

To reassign a trunk or pool to a new calling group, you must remove it from its old group before making the new assignment.

To assign trunks or pools to ring directly into a calling group:

- 1. From the System Programming menu, select Extensions.
  - On the console: Select Extensions.
  - On the PC: Press F6.

The Extensions menu appears.

- 2. Access the second screen of the Extensions menu.
  - On the console: Press More.
  - On the PC: Press (PgUp) .

- 3. Select Group Calling.
  - On the console: Select Grp Calling.
  - On the PC: Press F4.

The Group Calling menu appears.

- 4. Select Line/Pool.
  - On the console: Select Line/Pool.
  - On the PC: Press F10.

The Group Calling screen appears.

- 5. Enter the extension of the calling group (typically, 770).
- 6. Save your entry.
  - On the console: Select Enter.
  - On the PC: Press F10.
- 7. Enter the Line/Trunk number or pool number you want to assign.

#### **NOTE:**

If 801, 802, 803, etc. are in pool 70, then you must specify 70.

- 8. Save your entry.

- 9. Repeat Steps 7 and 8 as required for additional lines/pools.

## Hunt Type

The Group Calling menu appears.

- 4. Select Hunt Type.
  - On the console: Select Hunt Type.

The Group Calling screen appears.

- 7. Specify the hunt pattern as linear.

The Extensions menu appears.

- 2. Access the second screen of the Extensions menu.
  - On the console: Press More.
  - On the PC: Press (PgUp).
- 3. Select Group Calling.
  - On the console: Select Grp Calling.
  - On the PC: Press F4.

The Group Calling menu appears.

- 4. Select Group Coverage.
  - On the console: Select GrpCoverage.
  - On the PC: Press F3.

The Group Calling screen appears.

- 4. Access the second screen of the Group Calling menu.

- 6. Enter the extension number of the group.

## **Allowed Lists**

Use this procedure to establish Allowed Lists, consisting of telephone numbers that can be dialed from specified telephones, regardless of calling restrictions assigned to telephones.

A maximum of eight lists, numbered 0 through 7, with a maximum of 10 numbers each, numbered 0 through 9, is allowed, Each allowed number can be no more than 6 digits (an area code plus an exchange) or 6 digits with a leading 1, where required.

If you program 0 as the first digit of a list entry, any toll restriction assigned to the station is removed for calls that can be placed by a toll operator.

Special characters (such as "pause") are not permitted in Allowed List entries.

To establish Allowed Lists:

- 1. From the System Programming menu, select Tables.
  - On the console: Select Tables.
  - On the PC: Press F8.

The Tables menu appears.

- 2. Select Allowed Lists.
  - On the console: Select AllowList.
  - On the PC: Press F1.

The Allowed List screen appears.

If you do not enter a list number, List 0 appears.

    - On the PC: Press F9 and repeat Step 6.

Your previous entry is saved and the next service group operator is shown on line 1 of the screen.

- If the next service group operator is not sequential:
  - On the console: Select Enter and then select Exit. Repeat Steps 2-6.
  - On the PC: Press F10 and then press F5. Repeat Steps 2-6.

To save your entry when all entries are complete:

- On the console: Select Enter.
- On the PC: Press F10.
- 8. Return to the System Programming menu.
  - On the console: Select Exit two times.
  - On the PC: Press F5 two times.

# **Intuity System Administration**

# 6

This chapter describes how to administer the Intuity system for integration with the MERLIN LEGEND switch. To integrate with the MERLIN LEGEND system, the Intuity system needs to know the extension length being used.

This chapter also describes the procedure for entering the Routing Table, Business Schedules, and Holiday Schedules. These procedures are for new features not described elsewhere at this time. They are not unique to the MERLIN LEGEND system.

# Administering the Switch Interface

The Switch Link Administration screen must be filled out before the MERLIN LEGEND system and the Intuity system can be integrated. Use the following procedure:

- 1. Log in as craft.
- 2. Press ENTER to accept the AT386 default.

The INTUITY Administration menu is displayed.

3. Begin at the INTUITY Administration menu, and select the following sequence:

> Switch Interface Administration

The Switch Interface Administration screen is displayed. A sample screen is shown below:

- 4. Fill out the number of digits in the extension length. The MERLIN LEGEND dial plan must use either 3 digit or 4 digit fixed length extension. This information should be recorded on Worksheet A that you filled out in Chapter 2, "Planning the Integration" in this book.

# System Security and Toll Fraud

# A

Telecommunications fraud is the unauthorized use of another company's telecommunications service. This type of fraud has been in existence since the 1950's when AT&T first introduced Direct Distance Dialing (DDD).

Twenty years later, Remote Access became a target of individuals seeking unauthorized network access. Now, with the added capabilities of voice mail and automated attendant services, customer premises equipment-based toll fraud has expanded as a new type of communications abuse. With its subculture of "hackers" and "phreakers," telecommunications fraud has rapidly become a highly profitable criminal activity.

# **Protecting Your System**

Voice messaging toll fraud has risen dramatically in recent years. Now more than ever, it is imperative that you take steps to secure your system. Callers into the voice messaging/automated attendant system may transfer to an outgoing trunk if adequate security measures are not implemented. Callers who have unauthorized access to a voice mailbox can use it as a message drop for communications at your expense on your 800 numbers. Securing your system means protecting the switch, protecting the voice messaging system, and protecting any automated attendant applications.

#### **Switch Security**

The only tool a criminal needs to breach an inadequately secured system is a touch-tone telephone. If criminals can gain access to an inside dial tone, they will attempt to gain access to an outside line by using normal switch functions such as:

- Automatic Routing System (ARS) access codes
- Pool Access Codes

Someone, somewhere, has read the switch features and administration books and passed the information around.<sup>1</sup> If a criminal discovers a way to breach your system, they will pass that information around too. They can run up thousands of dollars of fraudulent calls in just a few hours. All security restrictions that prevent transfer to outside lines by unauthorized persons should be implemented.

#### **Security Tips**

To help prevent toll fraud at the switch, follow these guidelines:

- Assign toll restrictions to voice messaging system and automated attendant ports.
- If you do not to use the outcalling features of the voice messaging system, restrict the outward calling capability of all voice ports.
- Use a dial plan that does not allow extensions beginning with the same digits as ARS, TAC, or verification and test codes.
- Inform all system operators that they are not to dial outside calls. Request that operators report all attempts to bypass switch restrictions to the telecommunications department for repairs or to the corporate security office for investigation.
- Restrict the numbers for outcalling and AMIS with a disallowed list.

#### **Voice Messaging System Security**

Voice messaging systems have two areas of weakness:

- codes that transfer to inside or outside dial tone
- mailboxes that can be used as message drops

Once thieves transfer to inside dial tone, they have access to any unprotected switch features. Preventing this type of abuse requires security at both the switch and at the voice messaging system.

Once thieves break into a mailbox, they can use it as a message drop for untraceable calls or for illegal activities. If you have 800 lines that can connect to your voice messaging system, they can pass stolen information around at your expense using your 800 lines. If you have user administrable outcalling, they can pass stolen information around at your expense automatically. Preventing this type of abuse requires security at the voice messaging system and on the part of your subscribers.

- Cellular phones can be monitored. If a subscriber enters a mailbox number and a password on a cellular phone, the mailbox number and the password will be known to anyone listening.
- To break a password, every word in a computerized 100,000 word-processor spelling checker or dictionary can be tried in just a few minutes. In a slightly longer time, every digit combination from 1 to 100,000 can be tried.

#### **Security Tips**

To help prevent toll fraud at the voice messaging system, follow these guidelines:

- Do not create voice mailboxes before they are needed.
- Deactivate unassigned mailboxes. When an employee leaves the company, close or reassign the mailbox.
- Do not have permanent "guest" mailboxes (mailboxes without a physical extension that are loaned to outsiders for the duration of a project). If you need a guest mailbox, assign it when it is needed and deactivate or change its password immediately after it is no longer needed. Do not reassign a guest mailbox without changing the password.
- Lock out multiple unsuccessful attempts to enter a voice mailbox on a single call. (Allow no more than two or three attempts on the same call.)
- Do not use default initial passwords that follow any scheme. Have a list of random passwords and select one when you create the mailbox. Require that the mailbox owner personally appear at the corporate security office or telecommunications office to obtain the initial password. Go over the subscriber password guidelines with the subscriber when you give out the initial password.

- Make sure subscribers change the initial password the first time they log in to the AUDIX system by making the initial password shorter than the minimum password length.
- Use the password aging feature so that users must change their passwords monthly.
- Discourage the practice of writing down passwords, storing them, or sharing them with others.
- Restrict the use of outcalling to personnel who actually need it.
- Restrict the number of digits that can be used for outcalling to seven or ten if possible. (Outcalling to pagers may require more.)
- Inform all system operators that they are not to dial outside calls. Request that operators report all attempts to bypass switch restrictions to the telecommunications department for repairs or to the corporate security office for investigation.
- Inform subscribers that programming passwords onto auto-dial buttons is a breach of corporate security that will be recorded in their permanent employee records.
- Inform employees on how to report suspected toll fraud to the corporate security office.
- Monitor call detail recording (SMDR) reports, call traffic reports, AUDIX traffic reports, and other available reports regularly.

#### Automated Attendant System Security

Automated attendants are used by many companies to augment or replace a switchboard operator. When an automated attendant answers, the caller is generally given several options that are appropriate to the company's business.

- there may be other unstated options such as a code for dial tone or a code for transfers that allow criminals to access unanticipated parts of the telecommunications system
- [\*], [7] ([\*], [T]) will cause a transfer from the automated attendant to the voice messaging service
- even anticipated transfers may cause problems if they are not well thought out
- naive operators may dial an outside call for someone who has dialed 0 and complains of trouble making a call.

In some automated attendant systems, option 9 is to access dial tone.

#### **Security Tips**

To help prevent toll fraud at the automated attendant, follow these guidelines:

- Do not allow transfers to inside or outside dial tone.
- Restrict transfers to subscribers only.
- Inform all system operators that they are not to dial outside calls. Request that operators report all attempts to bypass switch restrictions to the telecommunications department for repairs or to the corporate security office for investigation.
- Inform employees on how to report suspected toll fraud to the System Administrator.
- Monitor call detail recording (SMDR) reports, call traffic reports, AUDIX traffic reports, and other available reports regularly.

# Subscriber Password Guidelines

To minimize the risk of unauthorized persons accessing subscriber mailboxes and using them for toll fraud, inform all subscribers of these guidelines and request that they follow these guidelines for voice messaging system passwords.

- Mailbox passwords are required.
- Require that passwords be as long as feasible, with a minimum of five digits, and a length that is at least one digit longer than the maximum extension length.
- Subscribers must change the initial password the first time they log in to the voice messaging system. To ensure this, the initial password should have fewer digits than the minimum password length.
- Never have greetings that state you will accept third party billed calls. A greeting like this allows unauthorized individuals to charge calls to your company. If a subscriber calls somebody within the company and receives a greeting like this, they should point out the vulnerability to the person and recommend that they change the greeting immediately.
- Never use obvious or trivial passwords such as your phone extension, room number, employee identification number, social security number, or the birthday of any family member. Also avoid easily guessed numeric combinations such as 1, 3, 9, 7 and 2, 4, 8, 6 (geometric pattern on the dial), 9, 9, 9, 9, 9, 9 (repeated digits), and 7, 2, 7, 7, 9, 6, 7, 3 ("password" spelled out on the dial).
- Passwords should not be written down, stored, or shared with others.

- Passwords must not be programmed into auto-dial buttons. Violation will result in an entry in the employees permanent personnel record.
- If subscribers receive any strange voice mail messages, find that their greeting or password has been changed, or suspect for any reason that their voice mailbox is being used by someone else, they should contact the System Administrator immediately.

### **Switch Administration**

The measures you can take to minimize the security risk of owning a telecommunications system depend on how the telecommunications system is used and how any associated voice messaging or automated attendant system is used.

To minimize the risk of unauthorized persons using the voice messaging or automated attendant systems to make toll calls, administer the voice ports on your switch in any of the following ways:

#### **Restrict Outward Dialing**

A voice port with outward restriction cannot make *any* outside calls unless an allowed number list is used for specific area codes and/or exchanges that can be called. Outward restriction prevents or limits outcalling and AMIS networking.

#### **Restrict Toll Areas**

A voice port with toll restriction cannot make toll calls, but it can still make local calls. Toll restriction may prevent or limit outcalling and AMIS networking. An allowed number list can be used for specific area codes and/or exchanges that can be called.

#### **Create Disallowed Number Lists**

When a voice port is unrestricted, or has toll restriction, a disallowed number list can be used to prevent calls to specific numbers, specific exchanges within all area codes, or specific numbers. There can be a maximum of eight disallowed lists in the MERLIN LEGEND system with a maximum of ten numbers on each list. Each voice port can be assigned any or all of the disallowed number lists.

#### **Create Allowed Number Lists**

When a voice port is outward or toll restricted, an allowed number list can be used to allow calls to specific area codes and/or exchanges. When outcalling or AMIS networking is required, using outward or toll restriction in combination with an allowed number list limits the risk of unauthorized persons using the voice messaging or automated attendant systems to make toll calls because calls can only be made to the specified area codes and/or exchanges.There can be a maximum of eight allowed lists in the MERLIN LEGEND system with a maximum of ten numbers on each list. Each voice port can be assigned any or all of the allowed number lists.

#### **Restrict AMIS Networking Number Ranges**

To increase security for AMIS analog networking, including the Message Delivery service, restrict the number ranges that may be used to address messages. If possible, also place outward or toll restriction on the voice ports and use an allowed number list.

### **Intuity AUDIX Administration**

To minimize the risk of unauthorized persons using the Intuity AUDIX system to make toll calls, administer the Intuity AUDIX system in any of the following ways:

#### Outcalling

Outcalling uses the voice messaging ports. If mailbox security is broken, unauthorized persons can use outcalling to transfer messages at your expense. If you need outcalling, restrict it as far as possible to eliminate the possibilities for theft of services.

- Do not enable outcalling at all if you don't need it.
- Do not enable outcalling for subscribers who don't need it.
- If outcalling is used only to ring in-house telephones that do not have message waiting lamps, restrict the number of digits to the maximum length of extensions.
- If possible, restrict outcalling to the local area (7 digits), or North America (10 digits).
- If outcalling must be done to pagers, use pagers that have individual DID numbers so that pager identification digits are not required and restrict any additional digits for caller identification to the minimum possible.
- If a limited number of pagers are in use, consider putting the pager numbers on an unrestricted calling list so that outcalling can be effectively limited to only those numbers.

#### **Mailbox Administration**

The use of Intuity AUDIX system security features in combination with mailbox administration can help reduce the risk of unauthorized use of mailboxes.

- Use the longest feasible password length. The Intuity AUDIX system allows passwords up to 15 digits, and you can specify the minimum number of digits required. Use a minimum of five digits, and a length at least one digit longer than the extension number length.
- Lock out multiple consecutive attempts to enter a voice mailbox. The Intuity AUDIX system has a password time-out feature that allows callers three attempts in one call to correctly enter their password before they are automatically disconnected. You can also specify how many consecutive invalid attempts are allowed before a voice mailbox is locked.
- Deactivate unassigned voice mailboxes. When an employee leaves the company, close or reassign the voice mailbox.
- Do not create voice mailboxes before they are needed.
- Avoid or closely monitor the use of "guest" mailboxes.

#### **Basic Call Transfer**

With Basic Call Transfer, when a caller enters [\*], [T], the Intuity AUDIX system processes the call as follows:

 The Intuity AUDIX system verifies that the digits entered contain the same number of digits as administered on the Intuity AUDIX system for extension length.

If call transfers are restricted to subscribers, the Intuity AUDIX system also verifies that the digits entered match the extension number for an administered subscriber.

2. If step 1 is successful, the Intuity AUDIX system performs a switch-hook flash, putting the caller on hold.



If step 1 is unsuccessful, the Intuity AUDIX system plays an error message and prompts the caller for another try.

- 3. The Intuity AUDIX system sends the digits to the switch.
- 4. The Intuity AUDIX system completes the transfer.

With Basic Call Transfer, a caller can dial any number provided the number of digits matches the length of a valid extension. If an unauthorized caller dials 9x11 (where "x" is 1 through 9), the call may go outside. Therefore extension numbers of the form 9x11 should not be used for mailboxes or for subscribers.

If call transfers are restricted to subscribers, a caller cannot initiate a transfer to an off-premises destination unless the digits entered match an administered subscriber's mailbox identifier. To ensure the integrity of the "subscriber" restriction, do not administer mailboxes that start with the same digit(s) as a valid switch trunk access code.

# **Detecting Toll Fraud**

Some of the Intuity system reports are valuable in determining if your voice messaging or automated attendant systems are being used for fraudulent purposes.

#### **Call Detail Recording**

With Station Message Detail Recording (SMDR) activated for incoming calls, you can check the calls into your voice mail ports. A series of short holding times may indicate repeated attempts to enter voice mailbox passwords.

Review SMDR reports for the following symptoms of voice messaging abuse:

- Short holding times on calls where voice messaging is the originating endpoint or terminating endpoint
- Calls to international locations not normal for your business
- Calls to suspicious destinations
- Numerous calls to the same number
- Undefined account codes

#### **NOTE:**

The MERLIN LEGEND system only records the last extension on the call. Internal toll abusers transfer unauthorized calls to another extension before they disconnect so that the SMDR does not track the originating station. If the transfer is to your voice messaging system, it could give a false indication that your voice messaging system is the source of the toll fraud.

Review the Call Accounting System (CAS) and HackerTracker documentation on how to use SMDR reports.

#### **Intuity AUDIX Traffic Reports**

The Intuity AUDIX system tracks traffic data over various timespans. Reviewing these reports on a regular basis helps to establish traffic trends. If increased activity or unusual usage patterns occur, such as heavy call volume on ports assigned to outcalling, they can be investigated immediately. In addition, the AUDIX Data Acquisition Package (ADAP) uses an external PC (running MS-DOS) to provide extended storage and analysis capabilities for the traffic data. You can also use the AUDIX Administration Log and Activity Log to monitor usage and investigate possible break-in attempts.

#### **AT&T's Statement of Direction**

The telecommunications industry is faced with a significant and growing problem of theft of customer services. No telecommunications system can be entirely free from risk of unauthorized use. But diligent attention to system management and to security can reduce that risk considerably. Often a tradeoff is required between reduced risk and ease of use and flexibility. Customers who use and administer their systems make this tradeoff decision. They know best how to tailor the system to meet their unique needs and, necessarily, are in the best position to protect the system from unauthorized use.

Because the customer has ultimate control over the configuration and use of AT&T services and products it purchases, the customer properly bears responsibility for fraudulent uses of those services and products.

To help customers use and manage their systems in light of the tradeoff decisions they make and to ensure the greatest security possible, AT&T commits to the following:

- AT&T products and services will offer the widest range of options available in the industry to help customers secure their communications systems in ways consistent with their telecommunications needs.

# Installing MERLIN LEGEND Software on the Intuity System

# К

This appendix provides procedures for installing the MERLIN LEGEND software on the Intuity system.



All software, including the MERLIN LEGEND Switch Integration (SWIN) Software and the MERLIN LEGEND System Programming and Maintenance (SPM) Software is installed at the factory. This procedure is needed only when a system has to be reinstalled in the field. Before you install the MERLIN LEGEND software, make sure that the voice system and maintenance software are installed.

To install the MERLIN LEGEND software, perform the following 4 procedures:

- 1. Stop the voice system.
- 2. Load the MERLIN LEGEND software.
- 3. Start the voice system.
- 4. Turn on Intuity AUDIX transfer feature.

Each of these procedures is described in the following sections.

# **Requirements**

Before you install the MERLIN LEGEND software, note the following requirements:

> Login: craft

Materials: MERLIN LEGEND Switch Integration Software (1 floppy disk)

> MERLIN LEGEND System Programming and Maintenance Software (1 floppy disk)

# **Procedure 1: Stop the Voice System**

Before you can load the MERLIN LEGEND software, you must stop the voice system.



# **CAUTION:**

All calls in progress will be disconnected.

To stop the voice system, use the following procedure:

- 1. Login as craft.
- 2. Press (ENTER) to accept the AT386 default.
- 3. The INTUITY Administration menu is displayed.
- 4. Begin at the INTUITY Administration menu, and select the following sequence:

> C	ustomer/Services Administration	
	> System Management	
	> System Control	
	>Stop Voice System	

The following message is displayed:

```
Enter y to continue, n to quit.
```

5. Enter y to continue.

The system will wait until all calls in progress disconnect before stopping the voice system. You will see a series of messages while the system is disconnecting calls.

When the process is finished, you will see the following messages:

The Voice System has stopped Press ENTER to continue...

6. Press (ENTER).

The System Control menu is redisplayed.

7. Press (CANCEL) until the INTUITY Administration menu is displayed.

You are now ready to load the MERLIN LEGEND software, as described in the following section.

# Procedure 2: Load the MERLIN LEGEND Software

- 1. Login as craft.
- 2. Press (ENTER) to accept the AT386 default.
- 3. The INTUITY Administration menu is displayed.
- 4. Begin at the INTUITY Administration menu, and select the following sequence:



The system responds with the Software Install Screen, as shown below:

5. Press (ENTER) to select the Floppy drive.

- 7. Press (ENTER) to install the software.

8. Press ENTER to accept the default of all.

You will see messages indicating the installation is still running. When the installation is complete, you see the following messages:

- 9. Remove the diskette from the floppy drive and insert the MERLIN LEGEND System Programming and Maintenance diskette.
- 10. Press (ENTER) to install the software.

11. Press (ENTER) to accept the default of all.

You will see messages indicating the installation is still running. When the installation is complete, you see the following messages:

Type [go] when ready
 or [q] to quit: (default: go)

- 12. Remove the diskette from the floppy drive.
- 13. Enter q to quit.

The Software Install screen is redisplayed.

14. Press CANCEL until the System Control menu is displayed.

You must now reboot the system.

15. Starting at the System Control screen, select:

> Shutdown Voice System

16. Press (ENTER) to shutdown the voice system.

The system responds:

Enter y to continue, no to quit

17. Enter y to continue the shutdown.

The system responds:

Shutdown started. Month date time year The system is coming down. Please wait

The system is down. Press CTRL-ALT-DEL to reboot your computer.

18. Press the reset button or CTRL-ALT-DELETE to reboot the system.

The system responds with memory checks, sets up new kernel, and lists packages and copyrights. The system also starts the voice system, displaying the message:

Startup of the Voice System is complete.

This procedure is finished when the console Login prompt appears.

### **Procedure 3: Turn on Transfer Feature**

After you install the MERLIN LEGEND software, you need to turn on the transfer feature in Intuity AUDIX. For this procedure, see *Intuity AUDIX Administration*, 585-310-539, and set the transfer type field to *basic*.

# Switch Administration for Intuity Lodging

# C

# Introduction

This chapter describes the switch administration you need to complete if you have Intuity Lodging. Read the information and configure your switch as required.

# Hunt Group Administration

A hunt group is a set of extension numbers assigned to another phone number. When a call is received by this number, a programmed search of the hunt group is made and the call is forwarded to a member of the hunt group that is not busy. For example, when two calls are made to the designated phone number, both are forwarded to two free extensions in the hunt group. Hunt groups are a commonly-used switch feature. Your switch probably has some hunt groups already assigned.

In order to configure a hunt group for calls being received by the Intuity system you must:

- 1. Administer your switch to create a hunt group for your Intuity system.
- 2. Have the switch ports that terminate the hunt group extensions wired to the voice ports on the Intuity platform. Wire them as described in one of the following documents, depending on your system:
- INTUITY<sup>™</sup> MAP/5 Hardware Installation, 585-310-146, Issue 2
- INTUITY<sup>™</sup> MAP/40 Hardware Installation, 585-310-138, Issue 2
- INTUITY<sup>™</sup> MAP/100 Hardware Installation, 585-310-139, Issue 2

# Message Retrieval Administration

The message retrieval number is the telephone number that subscribers call to retrieve voice mail messages. Like other calls to the Intuity system, message retrieval calls are ultimately forwarded to the Intuity hunt group.

# Message Retrieval in Lodging Systems without AUDIX

1. Provide the Intuity system's message retrieval number to your subscribers.

# Message Retrieval in Systems Shared with AUDIX

There must be two message retrieval numbers in a shared system, one to retrieve from the AUDIX application, and one to retrieve from the Lodging application.

#### **Retrieval from the AUDIX Application**

1. Provide the Intuity system message retrieval number to your subscribers for the AUDIX application.

#### **Retrieval from the Lodging Application**

- Administer on your switch an extension number *not* associated with a switch port. (These are often called *phantom* or *dummy* numbers.) This number becomes the Lodging message-retrieval number for your system.
- 2. Configure the Lodging message retrieval number so that the Intuity hunt group covers all calls.
- 3. Provide the Lodging message retrieval number to your subscribers for the Lodging application.

#### **Alternate Message Retrieval Method**

Guests can also be allowed to log on from a remote phone to any mailbox for which they have a password. A guest will call a number to access this service then enter an extension number and a password to retrieve messages in the mailbox.

To provide this service:

1. Administer on your switch a phantom number. This is the message retrieval number used from a remote phone.

- 2. Configure the phantom number so the Intuity system hunt group covers all calls.
- 3. If your switch has password capability, assign a password to the new extension.
- 4. Assign to the new extension, the service: "Idg\_ni\_vm."
  - a. Log on to the Intuity system as sa or craft.
  - b. From the Intuity Administration menu select the following sequence:.



- c. From the Voice Equipment screen, press (CHG-KEYS) (F8) then (ASSIGN) (F3).
- d. Select Services to Called Numbers from the Assign menu.
- e. Press (CHOICES) (F2) and select ldg\_ni\_vm.
- f. Enter the called number that was administered on the switch for this purpose.
- g. Press <u>SAVE</u> (F3). A command-output screen appears confirming your choice.
- h. Press CANCEL (F6) three times to exit to the Voice Equipment screen.
- 5. If the phantom extension is to be accessed from outside your system, assign the extension to a Direct-Inward-Dialing number.
- 6. Provide the Lodging message retrieval number to your subscribers for the Lodging application.

# **Voice Mail Administration**

Voice mail is enabled when the switch sends a guest's call to a coverage path. The following procedure, however, provides a separate number that can be used at any time to send voice mail to a guest.

To provide this service:

- 1. Administer on your switch a phantom number. This number is used to send voice messages to your subscribers.
- 2. Configure the phantom number so that the Intuity system hunt group covers all calls.
- 3. Assign to the new extension, the service: "ldg\_ni\_ca" as follows:
  - a. Log on to the Intuity system as sa or craft.
  - b. From the Intuity Administration menu select the following sequence:.

>Vo	pice System Administration	
	Voice Equipment	

- c. From the Voice Equipment screen, press CHG-KEYS (F8) then (ASSIGN) (F3).
- d. Select Services to Called Numbers from the Assign menu.
- e. Press (CHOICES) (F2) and select ldg\_ni\_ca
- f. Enter the called number of your choice.
- g. Press <u>SAVE</u> (F3). A command-output screen appears confirming your choice.
- h. Press CANCEL (F6) three times to exit to the Voice Equipment screen.
- 4. If the phantom extension will be accessed from outside your system, assign the extension to a Direct-Inward-Dialing number.
- 5. Provide the Lodging voice mail number to subscribers for the Lodging application.
# **Call Coverage Path**

A coverage path directs the switch to transfer unanswered calls to a hunt group, to a service, or to another extension.

When a call goes to coverage, the switch forwards the called number to the Intuity system. The Intuity system detects that the called number is administered as a specific subscriber's extension and treats the call as one to be answered and recorded. Depending on how the extension is configured, the call may be answered by either the AUDIX or the Lodging application.

 Administer your switch to assign call coverage for each guest's extension to the associated Intuity system hunt group number.

# **Do Not Disturb**

Look for features on your switch that adapt themselves especially well to lodging situations. One example is the *Do not Disturb* feature on some switches. This feature makes it possible to request that a particular extension not receive calls until a specified time. At the specified time, the switch automatically deactivates the feature and allows calls to terminate normally at the extension.

If this extension is covered by the Intuity system hunt group, then calls received while *Do-not-Disturb* is active will be recorded for later retrieval.

# **Cut-to-Service**

A cut-to-service of the Intuity Lodging application amounts to changing the coverage path for each guest extension to the Intuity system hunt group. The associated system must be completely installed before you cut the Intuity Lodging application into service. Furthermore, all Intuity system initial administration, associated switch administration, and acceptance tests must be completed.

Some switching systems make it possible to group these extensions as a set allowing the coverage path to be changed simultaneously. Most switching systems permit changing the coverage path for guest extensions one extension at a time. You may use either method.

# Gradual Cut-to-Service

Using this cut-to-service strategy, enter guests into the Intuity Lodging system as they check in. Only new guests, not current guests, receive Intuity Lodging services.

The advantages of this method include:

- Attendants can learn the new system while only a portion of guests are also learning to use it.
- Guests do not have to learn both the previous and the new systems. Current guests use the previous system; new guests use the Intuity Lodging system.
- Custom passwords and language options can be assigned to each guest as the guest is checked in.

Gradually cut to service as follows:

- 1. Administer your switch to send the guests' telephone call coverage to the Intuity system hunt group.
- 2. Check in each new guest as described in *Intuity Lodging Administration and Feature Operations*, 585-310-559.

# **One-Step Cut-to-Service**

On switches where a coverage path is separately defined and then applied to a class of stations, assign all guest stations to Intuity Lodging at once.

Using this cut-to-service strategy, all guest stations are changed to Intuity Lodging at the same time.

The advantages of this method include:

- Since Intuity Lodging is brought up in one step, attendants must cope with only one call-answering system at a time.
- Cut-to-service is over at once. Multiple messaging systems can confuse the guests.
- Reasonable coverage options can be assigned to all guests at once; administration can be modified for the few that have unusual requirements.

Cut to service as follows:

- 1. Use Intuity Lodging to administer the options that guests require.
- 2. Make sure guests and attendants know when the change will take place and have some idea of how the new service operates.
- 3. On your switch, determine the coverage path that applies to your guests' stations.
- 4. On your switch, set the new coverage path for your guests' stations to the Intuity system hunt group.

# Summary

You have completed the switch integration tasks necessary to configure your Intuity system for the Lodging application.

# **5ESS Switch**

An AT&T central office switch that can be integrated with the AT&T Intuity system.

# A

## accessed message

A message that was received and scanned (either the entire message or just the header).

# ACD

See automatic call distribution.

# activity menu

The list of options spoken to subscribers when they first access a messaging system. Selecting an activity is the starting point for all user operations.

# ADAP

See administration and data acquisition package.

# address

Intuity AUDIX subscriber identification, containing the subscriber's extension and machine, that indicates where the system needs to deliver a message. An address may include several subscribers or mailing lists. Name or number addressing can be selected with the \*A command.

#### adjunct

A separate system closely integrated with a switch, such as an AT&T Intuity system or a call management system (CMS).

## administration

The process of setting up a system (such as a switch or a messaging system) to function as desired. Options and defaults are normally set up (translated) by the system administrator or service personnel.

# administration and data acquisition package (ADAP)

A software package that allows the system administrator to transfer system subscriber, maintenance, or traffic data from an Intuity AUDIX system to a personal computer (PC).

# ADU

See asynchronous data unit.

## alarm log

A list of alarms that represent all of the active or resolved problems on an AT&T Intuity system. The alarm log is stored in a software file on disk and can be accessed either locally or remotely on a terminal connected to the system.

#### alarms

Hardware, software, or environmental problems that may affect system operation. Alarms are classified as major, minor, or warning.

# alphanumeric

Alphabetic, numeric, or punctuation symbols.

# ALT

See assemble load and test.

#### AMIS

See Audio Messaging Interchange Specification.

#### **AMIS Prefix**

A number added to the destination number to indicate that the destination number is an AMIS analog networking number.

# ampere (amp)

The unit of measurement of electric current. One volt of potential across one ohm causes a current flow of one amp.

## analog networking

A method of transferring a message from one messaging system to another whereby the message is played back (voiced) during the transmission from one system to another.

#### analog signal

A communications path that, in teleprocessing usage, usually refers to a voice-grade telephone line.

# announcement fragment

A numbered piece of spoken information that makes up a system message or prompt.

## antistatic

A material that is treated to prevent the build-up of static electricity.

#### API

See application programming interface.

# application programming interface

A set of formalized software calls and routines that can be referenced by an application program to access underlying network services.

## assemble load and test

The factory process that preloads software, installs hardware, and tests the system prior to shipping.

### asynchronous communication

A method of data transmission in which bits or characters are sent at irregular intervals and bits or characters are spaced by start and stop bits and not by time. See also *synchronous communication*.

### asynchronous data unit (ADU)

An electronic communications device that can extend data transmission over asynchronous lines more than 50 feet in length. Recommended ADUs include Z3A1 or Z3A4.

#### asynchronous transmission

A form of serial communications where each transmitted character is bracketed with a start bit and one or two stop bits. The AT&T Intuity system provides asynchronous RS-232 capabilities for Intuity AUDIX Digital Networking, if required.

# attendant console

A special purpose phone with numerous lines and features located at the front desk. The front desk attendant uses the phone to answer and transfer calls.

## Audio Messaging Interchange Specification (AMIS)

An analog networking protocol that allows subscribers to exchange messages with any messaging system that also has AMIS Analog Networking capabilities. Messages can be exchanged with subscribers on AT&T Intuity systems as well as with users on remote messaging systems made by vendors other than AT&T.

### Audio Information Exchange (AUDIX)

A complete messaging system accessed and operated by touch-tone telephones and integrated with a switch.

#### audit

A software program that resolves filesystem incompatibilities and updates restored filesystems to a workable level of service. Audits are done automatically on a periodic basis, or can be performed on demand.

# AUDIX

See Audio Information Exchange.

#### autodelete

An Intuity AUDIX feature that allows subscribers to indicate that faxes are automatically deleted from their mailbox after being printed.

#### automated attendant

A feature that allows a user of an Intuity system to set up a main extension number with a menu of options that routes callers to an appropriate department at the touch of a button.

#### automatic call distribution (ACD)

The System 85, Generic 2, or Generic 3 call-distribution group of analog ports that connects Intuity subscribers and users to the system. See also *call-distribution group*.

# automatic message scan

An Intuity AUDIX feature that allows subscribers to scan all message headers and messages at the touch of two buttons. With Intuity FAX Messaging, this feature allows all new faxes to be bundled and transmitted over a single fax call delivery call. Also called *autoscan*.

## autoprint

An Intuity AUDIX feature that allows subscribers to indicate that faxes are automatically sent to a specified print destination.

#### autoscan

See automatic message scan.

# AWG

See American wire gauge.

## American wire gauge

A standard measuring gauge for non-ferrous conductors.

# B

# background testing

Testing that runs continuously when the system is not busy doing other tasks.

# backup

A duplicate copy of files and directories saved on a removable media such as floppy diskette or tape. The backup filesystem may be copied back (restored) if the active version is damaged (corrupted) or lost.

#### basic input/output system (BIOS)

A system that contains the buffers for sending information from a program to the actual hardware device the information should go to.

#### baud

A unit of measurement that describes the speed of transferred information.

#### baud rate

Transmission signaling speed.

#### basic call transfer

A switch hook-flash method used to send the Intuity AUDIX transfer command over analog voice ports.

#### basic rate access

See basic rate interface.

#### basic rate interface (BRI)

International standard protocol for connecting a station terminal to an integrated systems digital network (ISDN) switch. ISDN BRI supports two 64 Kbps information bearer channels (B1 and B2), and one 16 Kbps call status and control (D) channel (a 2B + D format). Also called basic rate access.

#### binary digit (bit)

Two-number notation that uses the digits 0 and 1. Low-order bits are on the right (for example, 0001=1, 0010=2, and so forth). Four bits make a nybble; eight bits make a byte.

# binary synchronous communications (BSC)

A character-oriented synchronous link protocol.

#### BIOS

See basic input/output system.

#### bit

See binary digit.

#### body

The part of subscriber voice mail that contains the actual spoken message. For a leave word calling (LWC) message, it is a standard system announcement.

#### boot

The operation to start a computer system by loading programs from disk to main memory (part of system initialization). Booting is typically accomplished by physically turning on or restarting the system. Also called *reboot*.

### boot filesystem

The filesystem from which the system loads its initial programs.

#### bps (bits per second)

The number of binary units of information (1s or 0s) that can be transmitted per second. Mbps refers to a million bits per second; Kbps refers to a thousand bits per second.

# BRI

See basic rate interface.

#### broadcast messaging

An Intuity AUDIX feature that enables the system administrator and other designated users to send a message to all subscribers automatically.

#### BSC

See binary synchronous communications.

### buffer

Memory used to compensate for time differences in transmission by temporarily storing data.

## bulletin board

An Intuity AUDIX feature that allows a message to be played to callers who dial the extension. Callers cannot leave a message since it is a listen-only service. Also called *information service*.

# bundling

Combining several calls and handling them as a single call. See also automatic message scan.

#### bus

An electrical connection/cable allowing two or more wires, lines, or peripherals to be connected together.

#### busy-out/release

To remove an Intuity device from service (make it appear busy or in use), and later restore it to service (release it). The Intuity switch data link, voice ports, or networking ports may be busied out if they appear faulty or if maintenance tests are run.

#### byte

A unit of storage in the computer. On many systems, a byte is eight bits (binary digits), the equivalent of one character of text.

# С

### call accounting system (CAS)

A software device that monitors and records information about a calling system.

## call-answer

An Intuity AUDIX or AT&T Intuity Lodging feature that allows the system to answer a call and record a message when the subscriber is unavailable. Callers may be redirected to the system through the call coverage or call forwarding switch features. Intuity AUDIX subscribers may record a personal greeting for these callers.

#### call-answer language choice

The capability of subscriber mailboxes to accept messages in different languages. For the Intuity AUDIX application, this capability exists when the multilingual feature is turned on.

#### callback number

In AMIS analog networking, the telephone number transmitted to the recipient machine to be used in returning messages that cannot be delivered.

#### call coverage

A switch feature that defines a preselected path for calls to follow if the first (or second) coverage points are not answered. The Intuity system may be placed at the end of a coverage path to handle redirected calls through call coverage, send all calls, go to cover, etc.

#### call delivery

See message delivery.

#### call-distribution group

The set of analog port cards on the switch that connects subscribers and users to the Intuity system by distributing new calls to idle ports. This group (or split) is called automatic call distribution (ACD) on System 85, Generic 2, and Generic 3 and uniform call distribution (UCD) on System 75, Generic 1, and Generic 3. See also *automatic call distribution* and *uniform call distribution*.

## call management system (CMS)

An inbound call distribution and management reporting package.

#### called tone (CED tone)

The distinctive tone generated by a fax endpoint when it answers a call (constant 2100 Hz tone).

#### called subscriber information (CSI)

The identifier for the answering fax endpoint. This identifier is sent in the T.30 protocol and is generally the telephone number of the fax endpoint.

#### calling tone (CNG tone)

The distinctive tone generated by a fax endpoint when placing a call (constant 1100 Hz tone on for one-half second, off for three seconds).

# call vectoring

A System 85 R2V4, Generic 2, and Generic 3 feature that uses a vector (switch program), allowing a switch administrator to customize the behavior of calls sent to an automatic call distribution (ACD) group.

# card cage

An area within the Intuity hardware platform that contains and secures all of the standard and optional circuit cards used in the system.

## cartridge tape drive

A high-capacity data storage/retrieval device that can be used to transfer large amounts of information onto high-density magnetic cartridge tape based on a predetermined format. This tape is to be removed from the system and stored as a backup.

#### CAS

See call accouting system.

## **CED** tone

See called tone.

#### CELP

See code excited linear prediction.

### central office (CO)

An office or location in which large telecommunication machines such as telephone switches and network access facilities are maintained. In a CO, private customer lines are terminated and connected to the public network through common carriers.

#### central processing unit (CPU)

The component of the computer that manipulates data and processes instructions coming from software.

#### channel

A telecommunications transmission path for voice and/or data.

#### channel capacity

A measure of the maximum bit rate through a channel.

#### CICS

See customer information control system.

## class of service (COS)

The standard set of Intuity AUDIX features given to subscribers when they are first administered (set up with a voice mailbox).

### clear to send (CTS)

Located on Pin 5 of the 25-conductor RS-232 interface, CTS is used in the transfer of data between the computer and a serial device.

## client

A computer that sends, receives and uses data, but that also shares a larger resource whose function is to do most data storage and processing. For Intuity Message Manager, the subscriber's PC running Message Manager is the client. See also *server*.

# CMS

See call management system.

# CNG tone

See calling tone.

# СО

See central office.

## COS

See class of service.

# code excited linear prediction

An analog-to-digital voice coding scheme.

#### collocated

An Intuity system installed in the same physical location as the host switch. See also *local installation*.

#### collocated adjunct

Two or more adjuncts that are serving the same switch (i.e., each has voice port connections to the switch) or that are serving different switches but can be networked through a direct RS-232 connection due to their proximity.

#### comcode

AT&T's numbering system for telecommunications equipment. Each comcode is a nine digit number that represents a specific piece of hardware, software, or documentation.

### command

An instruction or request given by the user to the software to perform a particular function. An entire command consists of the command name and options. Also, one- or two-key touch tones that control a mailbox activity or function.

#### compound message

A message that combines both a message and a fax message into one unit, which is then handled by Intuity AUDIX as a single message.

#### configuration

The particular combination of hardware and software components selected for a system, including external connections, internal options, and peripheral equipment.

#### controller circuit card

A circuit card used on a computer system that controls its basic functionality and makes the system operational. These cards are used to control magnetic peripherals, video monitors, and basic system communications.

### COS

See class of service.

#### coverage path

The sequence of alternate destinations to which a call is automatically sent when the call is not answered by a subscriber. This sequence is set up on the switch, normally with the AT&T Intuity system as the last or only destination.

### CPU

See central processing unit.

#### cross connect

Distribution system equipment used to terminate and administer communication circuits.

#### cross connection

The connection of one wire to another, usually by anchoring each wire to a connecting block and then placing a third wire between them so that an electrical connection is made.

#### CSI

See called subscriber information.

# CTS

See clear to send.

# D

### DAC

See dial access code.

## database

A structured set of files, records, or tables. Also, a collection of filesystems and files in disk memory that store the voice and nonvoice (program data) necessary for AT&T Intuity system operation.

# data communications equipment (DCE)

Standard type of data interface normally used to connect to data terminal equipment (DTE) devices. DCE devices include the data service unit (DSU), the isolating data interface (IDI), and the modular processor data module (MPDM).

## data communications interface unit (DCIU)

A switch device that allows nonvoice (data) communication between an AT&T Intuity system and an AT&T switch. The DCIU is a high-speed synchronous data link that communicates with the

common control switch processor over a direct memory access (DMA) channel that reads data directly from FP memory.

#### data link

A term used to describe the communications link used for data transmission from a source to a destination. For example, a phone line for data transmission.

#### data service unit (DSU)

A device used to access digital data channels. DATAPHONE II 2500 DSUs are synchronous data communications equipment (DCE) devices used for extended-local AT&T Intuity system connections. The 2600 or 2700 series may also be used; these are more expensive DSU options and support diagnostic testing and the DATAPHONE II Service network system.

# data set

AT&T term for a modem. A data set usually includes the telephone. See also modem.

#### data terminal equipment (DTE)

Standard type of data interface normally used for the endpoints in a connection. Normally the AT&T Intuity system, most terminals, and the switch data link are DTE devices.

#### data terminal ready (DTR)

A control signal sent from the data terminal equipment (DTE) to the data communications equipment (DCE) that indicates the DTE is on and ready to communicate.

# DBP

See data base processor.

### DCE

See data communications equipment.

# DCIU

See data communications interface unit.

# DCP

See digital communications protocol.

# DCS

See distributed communications system.

#### debug

See troubleshoot.

# dedicated line

A communications path that does not go through a switch. A dedicated (hard-wired) path may be formed with directly connected cables. MPDMs, DSUs, or other devices may also be used to extend the distance that signals can travel directly through the building wiring.

#### default

A value that is automatically supplied by the system if no other value is specified.

## default print number

The subscriber-administered extension to which autoprinted faxes are redirected upon their receipt into the subscriber's mailbox. This default print destination is also provided as a print option when the subscriber is manually retrieving and printing faxes from the mailbox.

# delivered message

A message that has been successfully transmitted to a recipient's incoming mailbox.

## demand testing

Testing performed on request (usually by service personnel).

## diagnostic testing

A program run for testing and determining faults in the system.

#### dial-ahead/dial-through

The act of interrupting or preceding Intuity AUDIX system announcements by typing (buffering) touch-tone commands in the order the system would normally prompt for them.

## dialed number identification service (\*DNIS\_SVC)

An available channel service assignment on the AT&T Intuity system. Assigning this service to a channel permits the AT&T Intuity system to interpret information from the switch and operate the appropriate application for the incoming telephone call.

## DID

See direct inward dialing.

## digital

Discrete data or signals such as 0 and 1, as opposed to analog continuous signals.

#### digital communications protocol (DCP)

A 64 Kbps digital data transmission code with a 160 Kbps bipolar bit stream divided into two information (I) channels and one signaling (S) channel.

# digital networking

A method of transferring messages between messaging systems in a digital format. See also *Intuity AUDIX Digital Networking*.

## digital signal processor

A specialized digital microprocessor that performs calculations on digitized signals that were originally analog and then sends the results on.

### DIP

See data interface process.

#### **DIP** switch

See dual in-line package switch.

#### direct inward dialing

The ability for a caller outside a company to call an internal extension without having to pass through an operator or attendant.

### direct memory access (DMA)

A quick method of moving data from a storage device directly to RAM, which speeds processing.

#### directory

An Intuity AUDIX feature allowing you to hear a subscriber's name and extension after typing \*\*N at the activity menu. Also, a group of related files accessed by a common name in software.

#### display terminal

A data terminal with a screen and keyboard used for displaying AT&T Intuity screens and performing maintenance or administration activities.

## distributed communications system (DCS)

A network of two or more switches that uses logical and physical data links to provide full or partial feature transparency. Voice links are made using tie trunks.

## distribution list

See mailing list.

#### DMA

See direct memory access.

## DNIS

See dialed number identification service.

#### DSP

See digital signal processor.

#### DSU

See data service unit.

# DTE

See data terminal equipment.

# DTMF

See dual tone multifrequency.

#### dual in-line package (DIP) switch

A very small switch, usually attached to a printed circuit card, in which there are only two settings: on or off (or 0 or 1). DIP switches are used to configure the card in a semipermanent way.

#### dual language greetings

The capability of Intuity AUDIX subscribers to create personal greetings in two different languages — one in a primary language and one in a secondary language. This capability exists when the multilingual feature is turned on and the prompts for subscriber mailboxes can be in either of the two languages.

## dual tone multifrequency

A way of signaling consisting of a pushbutton or touch tone dial that sends out a sound which consists of two discrete tones picked up and interpreted by telephone switches.

# E

#### electrostatic discharge (ESD)

Discharge of a static charge on a surface or body through a conductive path to ground. An ESD can be damaging to integrated circuits.

#### enabled/disabled

The state of a hardware device that indicates whether the AT&T Intuity system can use it. Devices must be equipped before they can be enabled (made active). See also *equipped/unequipped*.

#### endpoint

See fax endpoint.

## enhanced call transfer

An Intuity AUDIX feature that allows compatible switches to transmit messages digitally over the BX.25 (data) link. This feature is used for quick call transfers and requires a fully integrated digital switch. Callers can only transfer to other extensions in the switch dial plan.

## enhanced serial data interface

A software- and hardware-controlled method used to store data on magnetic peripherals.

#### equipped/unequipped

The state of a networking channel that indicates whether AT&T Intuity software has recognized it. Devices must be equipped before they can be enabled (made active). See also *enabled/ disabled*.

#### error message

A message on the screen indicating that something is wrong and possibly suggesting how to correct it.

#### errors

Problems detected by the system during operation and recorded in the maintenance log. Errors can produce an alarm if they exceed a threshold.

#### escape from reply

The ability to quickly return to getting messages for a subscriber who gets stuck trying to respond to a message. To escape, the subscriber simply presses #.

# escape to attendant

An Intuity AUDIX feature that allows a subscriber with the call answer feature to have a personal attendant or operator administered to potentially pick up an unanswered call. A system-wide extension could also be used to send callers to a live agent.

# ESD

See electrostatic discharge.

#### events

Informational messages about the system's activities. For example, an event is logged when the system is rebooted. Events may or may not be related to errors and alarms.

# F

#### facility out-of-service

The current channel is not receiving a dial tone and is not functioning.

### fax endpoint

Any device capable of receiving fax calls. Fax endpoints include fax machines, individual PC fax modems, fax ports on LAN fax servers, and ports on fax-enabled messaging systems.

## field

An area on a screen, menu, or report where information can be typed or displayed.

#### **FIFO**

See first-in/first-out.

### file

A collection of data treated as a basic unit of storage.

#### filename

Alphanumeric characters used to identify a particular file.

#### file redundancy

See mirroring.

#### file system

A collection of related files (programs or data) stored on disk that are required to initialize an AT&T Intuity system.

#### first-in/first-out

The first call (or data) to be received is the first call (or data) to be processed.

# F key

See function key.

## FOOS

See facility out-of-service.

#### format

To set up a disk, floppy diskette, or tape with a predetermined arrangement of characters so that the system can interpret meaningful information.

#### function

Individual steps or procedures within a mailbox activity.

## function key (F key)

A key on a computer keyboard that performs a defined function when pressed. The user interface for the AT&T Intuity system defines keys F1 through F8.

# G

#### Generic 1, 2, or 3

AT&T switch system software releases. Generic 1, Generic 3i, and Generic 3s correspond to the new generation of System 75-based software. Generic 2 and Generic 3r correspond to the new release of System 85-based software.

### generic tape

A copy of the standard software and stand-alone tape utilities that is shipped with a new AT&T Intuity system.

#### GOS

See grade of service.

#### grade of service (GOS)

A parameter that describes the delays in accessing a port on the AT&T Intuity system. For example, if the GOS is P05, 95% of the callers would hear the system answer and 5% would hear ringing until a port became available to answer the call.

#### guaranteed fax

A feature of AT&T Intuity FAX Messaging that temporarily stores faxes sent to a fax machine. In cases where the fax machine is busy or does not answer a call, the call is sent to an Intuity AUDIX mailbox.

#### guest password

A feature that allows users who are not Intuity AUDIX subscribers to leave messages on the system by dialing a subscriber's extension and entering a system-wide guest password.

# Η

# hard disk drive

A high-capacity data storage/retrieval device that is located inside a computer platform. A hard disk drive stores data on non-removable high-density magnetic media based on a predetermined format for retrieval by the system at a later date.

## hardware

The physical components of a computer system. The central processing unit, disks, tape and floppy drives are all hardware.

#### header

Information that the system creates to identify a message. A message header includes the originator or recipient, type of message, creation time, and delivery time.

# help

A command run by pressing (HELP) or (CTRL)? on an AT&T Intuity display terminal to show the options available at your current screen position. In the Intuity AUDIX system, press (\*) (H) on the telephone keypad to get a list of options. See also *on-line help*.

#### hertz (Hz)

A measurement of frequency in cycles per second. A hertz is one cycle per second.

#### host switch

The switch directly connected to the AT&T Intuity system over the data link. Also, the physical link connecting an AT&T Intuity system to a distributed communications system (DCS) network.

#### hunt group

A group of analog ports on a switch usually administered to search for available ports in a circular pattern.

## Hz

See hertz.

# I

#### I/O

Input/output.

# IDI

See isolating data interface.

# IMAPI

See Intuity messaging application programming interface.

### INADS

See initialization and administration system.

## information service

See bulletin board.

#### initialization

The process of bringing a system to a predetermined operational state. The start-up procedure tests hardware; loads the boot filesystem programs; locates, mounts, and opens other required filesystems; and starts normal service.

## initialization and administration system (INADS)

A computer-aided maintenance system used by remote technicians to track alarms.

## initialize

To start up the system for the first time.

#### input

A signal fed into a circuit or channel.

## integrated services digital network (ISDN)

A network that provides end-to-end digital connectivity to support a wide range of voice and data services.

### integrated voice processing CELP (IVC6) card

A computer circuit card that supports both fax processing and voice processing capabilities. It provides two analog ports to support six analog channels. All telephone calls to and from the AT&T Intuity system are processed through the IVC6 card.

## integrated voice response

An application module that allows customers to write their own alternate applications, also known as a script builder.

## interface

The device or software that forms the boundary between two devices or parts of a system, allowing them to work together. See also *subscriber interface*.

#### interrupt request (IRQ)

A device that signals the data bus and the CPU that it needs attention.

## Intuity AUDIX Digital Networking

An AT&T Intuity feature that allows customers to link together up to 500 remote AT&T Intuity machines for a total of up to 500,000 remote subscribers. See also *digital networking*.

# **Intuity Message Manager**

A Windows-based software product that allows Intuity AUDIX subscribers to receive, store, and send their voice/FAX messages from a PC.

#### Intuity messaging application programming interface (IMAPI)

A software function-call interface that allows Intuity AUDIX to interact with AT&T Intuity Message Manager.

## I/O address

input/output address.

## IRQ

See interrupt request.

## ISDN

See integrated services digital network.

#### isolating data interface (IDI)

A synchronous, full duplex data device used for cable connections between an AT&T Intuity GPSC-AT/E card and the switch data communications interface unit (DCIU).

## IVC6

See integrated voice processing CELP (IVC6) card.

# IVR

See integrated voice response.

# J

## jumper

Pairs or sets of small prongs on circuit cards and mother boards that allow the user to instruct the computer to select one of its available operation options. When two pins are covered, an electrical circuit is completed.

# K

# Kbps

kilobits per second; one thousand bits per second.

## Kbyte

kilobyte per second; 1024 thousand bytes per second.

# L

## label

The name assigned to a disk device (either a removable tape cartridge or permanent drive) through software. Cartridge labels may have a generic name (such as 3:3) to show the software release or a descriptive name if for backup copies (such as back01). Disk drive labels usually indicate the disk position (such as disk00 or disk02).

# LAN

See local area network.

## last-in/first-out

The last call (or data) to be received is the first call (or data) to be processed.

# LCD

See liquid crystal display.

# leave word calling (LWC)

A switch feature that allows the calling party to leave a standard (nonvoice) message for the called party using a feature button or dial access code.

# LED

See light emitting diode.

## LIFO

See last-in/first-out.

#### light emitting diode (LED)

A light indicator on the hardware platform that shows the status of operations.

#### liquid crystal display (LCD)

The 10-character alphanumeric display that shows status of the system, including alarms.

load

To read software from external storage (such as disk) and place a copy in system memory.

### local area network (LAN)

A network of PCs that communicate with each other and that normally share the resources of one or more servers. Operation of AT&T Intuity Message Manager requires that the Intuity AUDIX system and the subscribers' PCs are on a LAN.

# local AUDIX machine

The AT&T Intuity system where a subscriber's Intuity AUDIX mailbox is located. All subscribers on this home machine are called *local subscribers*.

## local installation

A switch, adjunct, or peripheral equipment installed physically near the host switch or system. See also *collocated*.

## local network

An Intuity AUDIX Digital Network in which all AT&T Intuity systems are connected to the same switch.

#### login

A unique code used to gain approved access to the AT&T Intuity system. See also password.

#### login announcement

A feature enabling the system administrator and other designated users to create a mail message that is automatically played to all Intuity AUDIX subscribers every time they login to the system.

# LWC

See leave word calling.

# Μ

## magnetic peripherals

Data storage devices that use magnetic media to store information. Such devices include hard disk drives, floppy disk drives, and cartridge tape drives.

# mailbox

A portion of disk memory given to each subscriber for creating and storing outgoing and incoming messages.

#### mailing list

A group of subscriber addresses assigned a list ID# and public or private status. A mailing list may be used to simplify sending messages to several subscribers.

#### maintenance

The process of identifying system errors and correcting them, or taking steps to prevent problems from occurring.

#### major alarm

An alarm detected by AT&T Intuity software that affects at least one fourth of the AT&T Intuity ports in service. Often a major alarm indicates that service is affected.

#### MANOOS

See manually out-of-service.

## manually out-of-service

A unit has been intentionally taken out of service.

#### mean time between failures

The average time a manufacturer estimates before a failure occurs in a component or system.

#### megabyte

A unit of memory equal to 1,048,576 bytes (1024 x 1024). It is often rounded to one million.

#### memory

A device which can store logic states such that data can be accessed and retrieved. Memory may be temporary (such as system RAM) or permanent (such as disk).

#### menu tree

The way in which nested automated attendants are set up.

#### message categories

Groups of messages in Intuity AUDIX subscribers' mailboxes. Categories include new, unopened, and old for the incoming mailbox and delivered, accessed, undelivered, undeliverable (not deliverable), and file cabinet for the outgoing mailbox.

#### message delivery

An optional AT&T Intuity feature that permits subscribers to send messages to any touch-tone telephone, as long as the telephone number is in the range of allowable numbers. This feature is an extension of the AMIS analog networking feature and is automatically available when the AMIS feature is activated.

#### Message Manager

See Intuity Message Manager.

#### message-waiting indicator (MWI)

An indicator that alerts subscribers that they have received new mail messages. An MWI can be LED, neon, or audio (stutter dial tone).

#### message waiting lamp (MWL)

An lamp that alerts subscribers that they have received new mail messages. An MWL can be LED, neon, or audio (stutter dial tone). Also known as a message-waiting indicator.

#### migration

An installation that moves data from another messaging system to the AT&T Intuity system.

#### minor alarm

An alarm detected by maintenance software that affects less than one fourth of the AT&T Intuity ports in service, but has exceeded error thresholds or may impact service.

#### mirroring

An AT&T Intuity system feature that allows data from crucial filesystems to be continuously copied to backup (mirror) filesystems while the system is running. If the system has some problem where an original filesystem cannot be used, the backup filesystem is placed in service automatically.

#### mode code

A string of touch-tones from a MERLIN LEGEND switch. A mode code may send the AT&T Intuity AUDIX system information such as call type, calling party, called party, and on/off signals for message waiting lamps.

### modem

A device that converts data from a form that is compatible with data processing equipment (digital) to a form compatible with transmission facilities (analog), and vice-vera.

#### modular

A term that describes equipment made of plug-in units that can be added together to make the system larger, improve its capabilities, or expand its size.

#### modular processor data module (MPDM)

A data device that converts RS-232C or RS-449 protocol signals to digital communications protocol (DCP) used by System 75/85, Generic1, and Generic 3 switches. MPDMs may connect AT&T Intuity to a switch DCIU or SCI link or connect terminals to a switch port card.

## MPDM

See modular processor data module.

## MTBF

See mean time between failures.

# multi-application platform (MAP)

The computer hardware platform used by the AT&T Intuity system. Currently, a MAP/5, MAP/40, and MAP/100 are available.

### multilingual feature

A feature that allows simultaneously-active language announcement sets on the system. With this feature, mailboxes can be administered so that subscribers can hear prompts in the language of their choice.

# MWI

See message-waiting indicator.

# MWL

See message waiting lamp.

# Ν

## networking

See Intuity AUDIX Digital Networking.

## networking prefix

A set of digits that identifies an AT&T Intuity machine.

### night attendant

The automated attendant created on a MERLIN LEGEND switch that automatically becomes active during off-hours. The night attendant substitutes for one or more daytime attendants.

### not deliverable message

Al message that could not be delivered after a specified number of attempts. This usually means that the subscriber's mailbox is full.

# 0

## on-line help

An AT&T Intuity feature that provides information about AT&T Intuity user interface screens by pressing a predetermined key. See also *help*.

#### open systems interconnection (OSI)

Internationally accepted framework of standards for communication between two systems made by different vendors.

#### operating system (OS)

The set of programs that runs the hardware and interprets software commands.

#### option

A choice selected from a menu, or an argument used in a command line to modify program output by modifying the execution of a command. When you do not specify any options, the command will execute according to its default options.

#### OS

See operating system.

#### OSI

See open systems interconnection.

# outcalling

An AT&T Intuity feature that allows the system to dial subscribers' numbers to inform them they have new messages.

# outgoing mailbox

A storage area for subscribers to keep copies of messages for future reference or action.

# P

#### parallel transmission

The transmission of several bits of data at the same time over different wires. Parallel transmission of data is usually faster than serial transmission.

# password

A code assigned to every AT&T Intuity terminal user and Intuity AUDIX subscriber for security reasons. After dialing the system, subscribers must dial their personal password correctly to log on. Passwords are also assigned to local and remote networked machines to identify the machines or the network. See also *login*.

#### password aging

An Intuity AUDIX feature that allows administrators to set a length of time after which a subscriber's password expires. The subscriber is then forced to change the password.

## PBX

See private branch exchange.

#### PC

See power converter.

#### PDM (processor data module)

See modular processor data module (MPDM).

## PEC

See price element code.

### peripheral device

Equipment external to the AT&T Intuity cabinet, such as printers or terminals, necessary for full operation and maintenance of the AT&T Intuity system. Also called *peripherals*.

# personal directory

An Intuity AUDIX feature allowing each subscriber to create a private list of customized names.

#### personal fax extension

See secondary extension.

#### pinouts

The signal description per pin number for a particular connector.

# PMS

See property management system.

#### port

A connection or link between two devices, allowing information to travel to a desired location. For example, a switch port connects to an AT&T Intuity voice port to allow a subscriber to leave a message.

#### POST

See power-on self test.

#### priority call answer

An Intuity AUDIX feature that allows callers to designate a call answer message as a priority message. To make a message priority, the caller presses 2 after recording the message.

# priority messaging

An Intuity AUDIX feature that allows some subscribers to send messages that are specially marked and preferentially presented to recipients. See also *priority outcalling*.

#### priority outcalling

Works with the priority messaging feature by allowing the message recipient to elect to be notified by outcalling only when a priority message has been received. See also *priority messaging*.

#### private branch exchange (PBX)

An analog, digital, or electronic system where data and voice transmissions are not confined to fixed communications paths, but are routed among available ports or channels. See also *switch*.

#### private mailing list

A list of addresses that only the owning subscriber can access.

#### private messaging

A feature of Intuity AUDIX that allows a subscriber to send a message that cannot be forwarded by the recipient.

#### processor data module (PDM)

See modular processor data module (MPDM).

#### processor interface (PI)

A System 75, Generic 1, Generic 3i, Generic 3s, and Generic 3vs switch data link. Also called *processor interface board (PIB)*.

#### programmed function key

See function key.

#### property management system

Term used in hospitality industry referring to the database used by hotels for guest records and billing information.

#### protocol

A set of conventions or rules governing the format and timing of message exchanges (signals) to control data movement and the detection and possible correction of errors.

#### public mailing list

A list of addresses that any Intuity AUDIX subscriber can use if that subscriber knows the owner's list ID# and extension number. Only the owner can modify a public mailing list.

#### pulse-to-touchtone converter

A device connected to the switch that converts signals from a rotary phone to touch tones. This device allows callers to use rotary phones to access options in a subscriber's mailbox or to access options in an automated attendant.

# R

#### RAM

See random access memory.

#### random access memory (RAM)

The primary memory in a computer that can be overwritten with new information.

#### read-only memory

A memory device which is programmed at the factory and whose contents thereafter cannot be altered.

#### reboot

See boot.

# remote access

Sending and receiving data to and from a computer or controlling a computer with terminals or PCs connected through communications links.

## remote installation

A system, site, or piece of peripheral equipment that is installed in a different location from the host switch or system.

#### remote network

A network in which the systems are integrated with more than one switch.

#### remote service center

An AT&T or AT&T-certified organization that provides remote support to AT&T Intuity customers. Depending upon the terms of the maintenance contract, your remote service center may be notified of all major and minor alarms and have the ability to remotely log into your system and remedy problems.

## remote subscribers

Intuity AUDIX subscribers whose mailboxes reside on a remote Intuity AUDIX Digital Networking machine.

#### remote terminal

A terminal connected to a computer over a phone line.

## REN

See ringer equivalence number.

#### reply loop escape

An Intuity AUDIX feature that allows a subscriber the option of continuing to respond to a message after trying to reply to a nonsubscriber message.

#### reply to sender

An Intuity AUDIX feature that allows subscribers to immediately place a call to the originator of an incoming message if that person is in the switch's dial plan.

#### request to send (RTS)

One of the control signals on a RS-232 connector that places the modem in the originate mode so that it can begin to send.

#### restart

An AT&T Intuity feature that allows Intuity AUDIX subscribers who have reached the system through the call answer feature to access their own mailboxes by typing the \*R (Restart) command. This feature is especially useful for long-distance calls or for users who wish to access the AT&T Intuity system when all the ports are busy. Also, the reinitialization of certain software. For example, restarting the messaging system.

#### restore

The process of recovering lost or damaged files by retrieving them from available backup tapes, floppy diskette, or another disk device.

#### retention time

The amount of time messages are saved on disk before being automatically deleted from a subscriber's mailbox.

#### ringer equivalence number (REN)

A number required in the United States for registering your telephone equipment with the phone company.

## ROM

See read-only memory.

# **RS-232**

A set of standards developed by the Electrical Industries Association (EIA) that specifies various electrical and mechanical characteristics for interfaces between computers, terminals, and modems.

# RTS

See request to send.

# S

#### sales representative

An AT&T or AT&T-certified person who assists you in the purchasing, planning, and implementation of AT&T equipment and solutions.

## SCA

See switch communications adapter.

#### scan

To automatically play mail messages, headers, or both.

#### scheduled delivery time

A time and/or date that an Intuity AUDIX subscriber optionally assigns to a message that tells the system when to deliver it. If a delivery time is omitted, the system sends the message immediately.

## SCSI

See small computer system interface.

#### secondary extension

A second, fax-dedicated extension that directs incoming faxes directly into a subscriber's mailbox without ringing the telephone. The secondary extension shares the same mailbox as the voice extension, but acts like a fax machine. Also called *personal fax extension*.

#### serial transmission

The transmission of one bit at a time over a single wire.

#### server

A computer that processes and stores data that is used by other smaller computers. For AT&T Intuity Message Manager, Intuity AUDIX is the server. See also *client*.

## shielded cables

Cables that are protected from interference with metallic braid or foil.

#### SID

See switch integration device.

## SIMMs

See single in-line memory modules.

#### simplified message service interface (SMSI)

Type of data link connection to an integrated 1A ESS switch or 5ESS switch in the AT&T Intuity system.

#### single in-line memory modules (SIMMs)

A method of containing random access memory (RAM) chips on narrow circuit card strips that attach directly to sockets on the CPU circuit card. Multiple SIMMs are sometimes installed on a single CPU circuit card.

#### small computer systems interface (SCSI)

An interface standard defining the physical, logical, and electrical connections to computer system peripherals such as tape and disk drives.

## SMSI

See simplified message service interface.

#### split

Group (or queue) of analog ports on the switch. See also call-distribution group.

#### subscriber

An AT&T Intuity user who has been assigned the ability to access the Intuity AUDIX Voice Messaging system.

#### subscriber interface

The devices that subscribers use to access their mailboxes, manage mailing lists, administer personal greeting, and use other messaging capabilities. Subscriber interfaces include a touch-tone telephone keypad and a PC using AT&T Intuity Message Manager.

# surge

A sudden voltage rise and fall in an electrical circuit.

## surge protector

A device that plugs into the phone system and the commercial AC power outlet. It is designed to protect the phone system from high voltage surges that could be damaging to the phone system.

# SW

See switch integration.

#### switch

An automatic telephone exchange that allows the transmission of calls to and from the public telephone network. See also *private branch exchange (PBX)*.

#### switched access

A connection made from one endpoint to another through switch port cards. This allows the endpoint (such as a terminal) to be used for several applications.

# switch hook

The device at the top of most telephones which is depressed when the handset is resting in the cradle (on hook). This device is raised when the handset is picked up (the phone is off hook).

## switch hook flash

A signaling technique in which the signal is originated by momentarily depressing the switch hook.

#### switch integration

Sharing of information between a messaging system and a switch in order to provide a seamless interface to callers and subscribers.

## switch integration device

Operates as a digital telephone set emulator.

## switch network

Two or more interconnected switching systems.

#### synchronous communication

A method of data transmission in which bits or characters are sent at regular time intervals, rather than being spaced by start and stop bits. See also *asynchronous communication*.

#### synchronous transmission

A type of data transmission where the data characters and bits are exchanged at a fixed rate with the transmitter and receiver synchronized. This allows greater efficiency and supports more powerful protocols.

## system configuration

See configuration.

#### Т

#### T.30

The standard for Group III fax machines that covers the protocol used to manage a fax session and negotiate the capabilities supported by each fax endpoint.

#### tape cartridge

One or more spare removable cartridges required to back up system information.

#### tape drive

The physical unit that holds, reads, and writes magnetic tape.

### TCP/IP

See transmission control protocol/internet program.

# TDD

See telecommunications device for the deaf.

#### TDM

See time division multiplex.

#### telecommunications device for the deaf (TDD)

A device with a keyboard and display unit that connects to or substitutes for a phone. The TDD allows a deaf or hearing-impaired person to communicate over the phone lines with other people who have TDDs. It also allows a deaf person to communicate with the Intuity AUDIX system.

#### terminal

See display terminal.

# terminal type

A number indicating the type of terminal being used to log on to the AT&T Intuity system. Terminal type is the last required entry before gaining access to the AT&T Intuity display screens.

#### terminating resistor

A grounding resistor placed at the end of bus, line, or cable to prevent signals from being reflected or echoed.

## time division multiplex

A device which derives multiple channels on a single transmission facility by connecting bit streams one at a time at regular intervals.

#### tip/ring

A term used to denote the analog telecommunications interface.

#### tone generator

A device acoustically coupled to a rotary phone, used to produce touch-tone sounds when subscribers cannot use a regular touch-tone generating voice terminal.

#### traffic

The flow of attempts, calls, and messages across a telecommunications network.

#### translations

Software assignments that tell a system what to expect on a certain voice port or the data link, or how to handle incoming data. They customize the AT&T Intuity system and switch features for users.

#### transmission control protocol/internet program (TCP/IP)

A set of protocols developed by the Department of Defense to link dissimilar computers across many kinds of networks. It is the protocol commonly used over Ethernet, as well as x.25, networks. Although committed to an eventual migration to an Open Systems Interconnection (OSI) architecture. TCP/IP currently divides networking functionality into only four layers: network interface, Internet, transport, and application.

## T/R

See tip/ring.

### troubleshoot

The process of locating and correcting errors in computer programs. Also called debug.

# U

# UCD

See uniform call distribution.

## Undelete

An Intuity AUDIX feature that allows subscribers to restore the last message deleted. The subscriber presses \* U to restore a deleted message.

### undelivered message

A message that has not yet been sent to an Intuity AUDIX subscriber's incoming mailbox. The message resides in the sender's outgoing message and may be modified or redirected by the sender.

### Unequipped

See equipped/unequipped.

#### unfinished message

A message that was recorded but not approved or addressed, usually the result of an interrupted Intuity AUDIX session. Also called *working message*.

### uniform call distribution (UCD)

The type of call-distribution group (or hunt group) of analog port cards on some switches that connects subscribers and users to the Intuity AUDIX system. System 75, Generic 1, Generic 3, and some central office switches use UCD groups. See also *call-distribution group*.

#### uninterruptable power supply

An auxiliary power unit for a telephone system that provides continuous power in cases where commercial power is lost.

# UNIX operating system

A multi-user, multi-tasking computer operating system.

#### upgrade

An installation that moves an AT&T Intuity system to a newer release.

#### untouched message

An Intuity AUDIX feature that allows a subscriber to keep a message in its current category by using the \*\*H (Hold) command. If the message is in the new category, message-waiting indication remains active (for example, the message-waiting lamp will remain lit).

## UPS

See uninterruptable power supply.

## U. S. 123

An alternate announcement set in U. S. English whose prompts use numbers, not letters, to identify phone keypad presses. For example, a prompt might say, "press star three," instead of, "press star D."

#### user population

A combination of light, medium, and heavy users on which AT&T Intuity configuration guidelines are based.

# V

#### vector

A customized program in the switch for processing incoming calls.

# voice link

The AT&T Intuity analog connection(s) to a call-distribution group (or hunt group) of analog ports on the switch.

### voice mail

See voice message.

## voice mailbox

See mailbox.

#### voice message

Digitized information stored by the AT&T Intuity system on disk memory. Also called voice mail.

#### voice port

The IVC6 port that provides the interface between the AT&T Intuity system and the analog ports on the switch.

# voice terminal

A telephone used for spoken communications with the AT&T Intuity system. A touch-tone telephone with a message-waiting indicator is recommended for all Intuity AUDIX subscribers.

## voicing

Either speaking a message into the AT&T Intuity system during recording, or having the system playback a message or prompt to a subscriber.

#### volt

The unit of measurement of electromotive force. One volt is the force required to product a current of one ampere through a resistance of one ohm.

# W

#### watt

A unit of electrical power that is required to maintain a current of one amp under the pressure of one volt.
